- Profit After Tax has increased by 40.12% to Rs.308.10 Crores during the year 2016-17 from Rs.219.89 Crores in previous year.

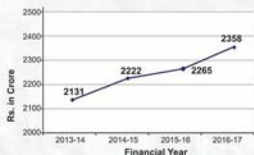
GROSS PROFIT - NET PROFIT(NP) AND NP AS % OF EXTERNAL SALES



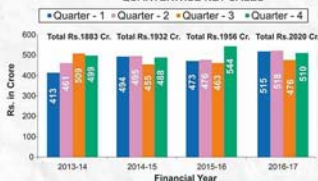
SHARE CAPITAL, RESERVES & SURPLUS, NET WORTH, BOOK VALUE PER EQUITY SHARE & EPS

The Company holds 60% and NALCO holds 40% in JV Company. Accordingly, GNAL is a subsidiary of the Company.

The Managing Director of the GACL is the Chairman of the JV Company. The Managing Director of the GACL does not draw any commission or any remuneration from GNAL except the Sitting Fees of Rs.2,500/- and incidental expenses of Rs.2,500/- per meeting for attending the meetings of the Board of Directors or Committees thereof. The Sitting Fees are paid by GNAL directly to GACL.

As per Section 129(3) of the Companies Act, 2013 read with Rule 5 of the Companies (Accounts) Rules, 2014, a separate statement containing the salient features of financial statement of the Joint Venture / Subsidiary Company in Form AOC-1 forms part of the Annual Report.

In accordance with the provisions of Section 136 of the Companies Act, 2013, the Annual Report of the Company, containing therein its standalone and consolidated financial statements have been placed on the website of the Company at www.gacl.com Further, the Audited Annual Accounts of the GNAL are also placed on the website of the Company at www.gacl.com The Interested Shareholders may obtain a physical copy of the audited financial statements of the Subsidiary Company by sending a request to the Company Secretary at the Company's Registered Office.

INTERNAL CONTROL SYSTEM AND THEIR ADEQUACY

The Company has in place adequate internal financial controls with reference to financial statements. During the year, such controls were tested and no reportable material weakness in the design or operation of Internal Control System was observed. As per the relevant provisions of the Companies Act, 2013, the Statutory Auditors have expressed their views on the adequacy of Internal Financial Control in their Audit Report.

RISK MANAGEMENT

The Company has constituted Internal Risk Management Committee comprising of Senior Executives of the Company who are heading respective departments viz. The Executive Director (Finance) & CFO is the Chairman of the Internal Risk Management Committee. The Internal Risk Management Committee reports to the Managing Director and the risks identified by the said Committee along with proposed mitigation actions are discussed periodically with the Managing Director.

The said Risk Management Committee has been renamed as "Risk Management-cum-Safety Committee" w.e.f. 10th November, 2016 by the Board. The existing Internal Risk Management Committee of Senior Executives of the Company continues to function. Out of the various risks identified by the Internal Risk Management Committee, the Audit Committee has identified certain critical risks, which are reviewed by the Risk Management-cum-Safety Committee, Audit Committee and by the Board of Directors on quarterly basis. A Report on the steps taken to mitigate those critical risks is also submitted to the Risk Management-cum-Safety Committee, Audit Committee and the Board of Directors.

VIGIL MECHANISM / WHISTLE BLOWER MECHANISM

The Government of Gujarat vide Resolution No. GAC/11-2006/4253/E dated 31.08.2016 appointed Dr. J N Singh, IAS, Chief Secretary to Government of Gujarat as Chairman of the Company as per the Articles of Association of the Company.

Pursuant to Section 161(1) of the Companies Act, 2013, Shri Anil Mukim, IAS and Shri M K Das, IAS have been appointed by the Board as Additional Directors effective from 15.10.2016 and 03.08.2017, respectively who shall hold office up to the date of this Annual General Meeting and their appointment as Directors liable to retire by rotation are proposed at this Annual General Meeting.

Shri P K Gera, IAS, Managing Director of the Company is not liable to retire by rotation as per the provisions of the Articles of Association of the Company, since he is appointed by the Government of Gujarat. However, this year, no other Director is retiring by rotation and to comply with the provisions of Section 152 of the Companies Act, 2013, it is proposed that Shri P K Gera, IAS, may retire as Director and may be reappointed at this Annual General Meeting as a Director. His terms and conditions for appointment as Managing Director does not change.

Thus, as on the date of this Report, there are eight (8) Directors on the Board of the Company. The Chairman and four (4) Independent Directors are Non-Rotational Directors, two (2) Directors viz. Shri Anil Mukim, IAS and Shri M K Das, IAS are Rotational Directors who will be first time appointed / regularized at this Annual General Meeting by shareholders and Shri P K Gera, IAS as Director will retire by rotation at this Annual General Meeting and being eligible has offered himself for re-appointment as Director.

A brief resume of these three Directors viz. Shri P K Gera, IAS, Shri Anil Mukim, IAS and Shri M K Das, IAS forms part of the Notice of this Annual General Meeting.

Pursuant to provisions of Section 203 of the Companies Act, 2013, Shri P K Gera, IAS, Managing Director was also appointed by the Board as Key Managerial Personnel of the Company effective from 19.02.2016. Dr. H B Patel, Chief Financial Officer and Shri Sanjay S Bhatt, Company Secretary are the Key Managerial Personnel of the Company effective from 14.05.2014.

The Company has received necessary declarations from the Independent Directors under Section 149(7) of the Companies Act, 2013, that he / she meets the criteria of independence laid down in Section 149(6) of the Companies Act, 2013 and Regulation 25 of the Listing Regulations.

The Internal Auditors independently evaluate the internal controls, adherence to and compliance with the procedures, guidelines and statutory requirements. The Audit Committee of Directors periodically reviews the reports of the Internal Auditors and the corrective actions, if any, are taken by the Management.

B. Statutory Auditors

M/s. Deloitte Haskins & Sells, Chartered Accountants, Vadodara (Firm Regn. No. 117364W) were appointed as the Statutory Auditors of the Company from the conclusion of 41st Annual General Meeting till the conclusion of 46th Annual General Meeting i.e. for a period of five years (subject to ratification of the appointment by the members at every AGM). A. CONSERVATION OF ENERGY:

(i) Steps taken or impact on conservation of energy:

1. Replacement of old 2nd generation elements with new energy efficient 6th generation elements and 5B+ generation elements at Vadodara and Dahej Complexes.
2. Replacement of H₂ cooler with new H₂ recuperator in KOH Plant.
3. Installation of new PHE of MC I drying tower and hence, stoppage of one 78% circulation pump.
4. Revamping of H₂O₂ Hydrogen Compressor.
5. Replacement of two cooling tower pumps of higher capacity with same rating motor.
6. Replacement of existing NaCl CDU pump in MC I with lower rating motor.
7. Replacement of old 98% H₂SO₄ pump with PFA lined pump.
8. HPMV fittings have been replaced with LED light fittings at various locations.
9. Utilization of vapor condensate of CEU for preparation of SBS solution instead of DM water.
10. Replacement of 2 x 36W and 1 x 36W Tube light fittings by 18W LED type Tube light fittings in CSL Plant, 80W x 125W HPMV well glass fittings with 40W LED type well glass fittings and 250W street light fittings by 56W LED type street light fittings in CSL, CLM and H₂O₂ Plants.
11. Installation of new energy efficient 30 TPH Boiler at CLM plant.
12. Replacement of CEU day tank pumps motors with IE2 type high efficient motor.
13. Replacement of 110 kVAR Capacitor in substation 2 switchyard and addition of 168 kVAR Capacitor by replacing 180 kVAR series reactor with 303 kVAR series reactor in capacitor bank.
14. KVV installed in Boiler No. 3 for steam generation.
15. Installation of Waste Heat Boiler in CLM plant.

(ii) Steps taken by the Company for utilizing alternate sources of energy:

The Company had taken up Wind Farm Projects of 14.7 MW capacity at Kuchhadi, Dist. Porbandar, Gujarat, which was commissioned in March, 2017. The total installed Wind Energy Generation capacity of the Company has increased to 171.45 MW after this installation.

The Company has also taken up 15 MW Solar Power Project for captive use and to meet the Solar Renewable Purchase Obligations. The Project is expected to be commissioned during the Financial Year 2017-18.

(iii) The Capital Investment on Energy Conservation equipments:

During the Financial Year 2016-17, the Company has invested Rs.134.73 crores as Capital Investment on Energy Conservation equipments and saving of Rs.31.78 crores have been achieved.

B. TECHNOLOGY ABSORPTION

(i) Major efforts made towards technology absorption:

For the production of Caustic Soda in electrolysis process, the Company uses electrolyser elements (anodes and cathodes) imported from Thyssenkrupp, Germany. In an effort to modernize the electrolysis operation, the Company has taken up activities for the replacement of old generation electrolyser elements (Generation I & II) with the latest new generation VB+ elements both at Vadodara and Dahej Complexes. In its first phase of such replacement, the Company has installed 915 new energy efficient VB+ elements at Vadodara Complex and 440 such elements at Dahej Complex and the same were successfully commissioned in a phased manner by February, 2017.

The other activities like in depth studies on raw material, intermediate process stages, monitoring of liquid & solid discharges and efforts on their reduction / value addition continued during the Financial Year. The efforts resulted to absorb the different technologies already in operation.

(ii) The benefits derived like product improvement, cost reduction, product development or import substitute:

- a. The Company was able to reduce the power cost per MT of Caustic Soda by about 10% during the Financial Year.
- b. The R&D efforts on captive consumption of in house developed cooling water treatment formulations, cleaning formulations, defoamer, technical support to other functions, re-fabrication of spent catalyst have resulted into appreciable savings.
- c. The efforts made on the stabilisation of Sodium Chlorate process have resulted in to the optimum utilisation of plant capacity.

In our vendor meet during 2016-17, we had appealed them to follow environment friendly processes, materials in their business. We also requested to use environment friendly material for packaging.
 - i. If yes, what percentage of your inputs was sourced sustainably ?
Few major activities of sustainable sourcing are mentioned hereunder:-
 - We have drastically reduced uses of papers for official use, sending purchase enquiries, printing of purchase orders, internal communications etc., instead of we are using electronic communications.
 - We are procuring Salt worth of Rs. 7,000 Lakhs (12% of total procurement) annually which is manufactured from water that does not contain any chemicals, hence, it is not harmful to environment. Our most of the salt suppliers are falling in small scale category, hence, indirectly we are providing an employment to unskilled people as a part of our social responsibilities.
 - We are procuring HM HDPE Carboys, barrels and various MS drums worth of Rs. 3,500 Lakhs (6% of total procurement). Scrap generated in the process of above materials are recyclable in nature and does not create any environmental issues.
 - We are procuring Potassium Chloride quantity 32,000 MT (33% of total spent value of imported items) annually from M/s. Canpotex Ltd., Canada. Initially, we were using inland transportation of material by road and now by rail transportation which helped to protect the environment by reducing fuel consumption.
 - We are also exploring to get shipment of Potassium Chloride from M/s. Canpotex Ltd., Canada at Kandla Port instead of Kakinada Port. Thus, total distance of inland transport will be reduced that will help us to save fuel.
 - Our major suppliers of Electrical and Instrumentation items are environment cautious and acquired certificates like ISO 14001 and OHSAS.
 - Some of our major suppliers of materials who have certificates like ISO 14001 and OHSAS.

Above are few examples and we are further trying to adopt sustainable sourcing in other area of our business.

Many suppliers in these regions are small suppliers from whom we are procuring the material. The Company procures salt from Co-operative Society at Bhavnagar. Also, the Company procures other material like consumable and engineering items from local and small suppliers.
The Company had participated in the event organized by Confederation of Indian Industry (CII), Vadodara to support Micro, Small and Medium Enterprises (MSME) and interacted with them to explore business opportunity to form mutual benefits.

The Company has planted more than 1,00,000 plants and it keeps maintaining the same. With tree plantation being a regular feature, it plants 1,000 sapling every year. Rainwater harvesting and collection is a part of routine activity at GACL. This water is then utilized for the maintenance of green belts. The vermiculture concept has been implemented in the premises to convert waste generated by the canteen, gardens and plants to vermicompost.



GACL has been a pioneer in adopting the environment friendly and energy efficient technologies. It converted to Membrane Cell Technology from Mercury Cell Technology way back in 1989 and since 1994 all the plants are running on Mercury free Membrane Cell Technology.

As a matter of strategy, the Company has placed sensors at strategic locations in and around the complex to monitor ambient air quality. For disposal of solid waste, GACL has secured dedicated landfill site conforming to the Hazardous Waste Management Act. Being a member of Effluent Channel Project, it releases its liquid effluent in the channel and adheres to the necessary parameters of the Gujarat Pollution Control Board before discharging it into the channel. - (vi) Comparison of the remuneration of the Key Managerial Personnel against performance of the Company :
The remuneration of the Managing Director is decided by the Government. The remuneration of all employees including Key Managerial Personnel other than Managing Director is revised at end of every 4 years and the same will be revised in the year 2017. Therefore, there is no direct relationship between the performance of the Company and remuneration of KMP except performance incentive pay (as mentioned at (v) above). As per the terms of appointment of the Managing Director, he is entitled for annual 3% increase in Basic Pay and the other KMPs are entitled for 5% annual increase in Basic Pay and D.A.(Base pay). There is no variable component in the remuneration of the Managing Director or any Director. However, in case of management category employees of the Company, 10% of Fixed CTC is performance incentive which is released on completion of the year and subject to individual performance of each employee and overall performance of the Company. The payment is made in the range of 5% to 15% of Cost to the Company (CTC) based on the combined rating of individual and organization performance.
- (vii) a) Variations in the market capitalization of the Company :
The market capitalization as on 31st March, 2017 was Rs. 2,994.76 crores (Rs.1,215.75 crores as on 31st March, 2016) at National Stock Exchange of India Ltd. (NSE).

DIVIDEND DISTRIBUTION POLICY

1. INTRODUCTION

The Securities and Exchange Board of India (SEBI), on July 8, 2016, has notified the SEBI (Listing Obligations and Disclosure Requirements) (Second Amendment) Regulations, 2016 and inserted new Regulation 43A after the Regulation 43 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Regulation 43A states that top five hundred listed companies based on market capitalization (calculated as on 31st March of every Financial Year) shall formulate Dividend Distribution Policy, which shall be disclosed in their Annual Reports and on their websites.

2. OBJECTIVE AND SCOPE

The Company has become one of the top five hundred listed companies as per the market capitalization as on 31st March, 2017 as per the requirements under Regulation 43A of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. Therefore, the Company has formulated Dividend Distribution Policy which is approved by the Board of Directors at its 361st meeting held on 26th May, 2017.

3. DEFINITIONS

"Act" means the Companies Act, 2013 and Rules framed thereunder, including any amendments, modifications, clarifications or re-enactment thereof.

"Board of Director or Board" means Board of Directors of the Company.

"Company" means Gujarat Alkalies and Chemicals Limited.

"Dividend" means Dividend as defined under the Companies Act, 2013.

"Policy" means this Dividend Distribution Policy.

"Listing Regulations" means SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, including any amendments, modifications, clarifications or re-enactment thereof.

4. APPLICABILITY AND EFFECTIVE DATE

This Policy shall be applicable to the Company with effect from the date of its approval by the Board, i.e. 26th May, 2017.

This Policy shall not apply to –

- Determination and declaring dividend on preference shares, if any, to be issued by GACL at a later date, as the same will be as per the terms of issue to be approved by the shareholders;
- Distribution of dividend in kind i.e. Issue of bonus shares or other securities by the Company;
- Buyback of equity shares.

5. STATUTORY REQUIREMENTS

The Board while taking decision of a dividend payout during a particular Financial Year, will comply with the statutory requirements including the Companies Act, 2013 and rules made thereunder.

Further, the Board of Directors will also take a decision to declare/recommend dividend after taking into account the Profits of the Company after providing depreciation as per the provisions of the Companies Act, 2013 and after transferring to the reserves such amount as may be required under Law and/or as may be considered appropriate by the Board.

In case of Interim Dividend, the profits as per the unaudited results for/upto the last quarter (after providing depreciation as per the Companies Act, 2013) which have been approved by the Board and for which limited review as per "Listing Regulations" has been carried out shall be considered. The Board will also take into consideration, the perception of the management with regard to, likely profits in the remaining part of the Financial Year, the prevailing and likely future prices of the products, future capital expenditure plans, likely maturity of short term liabilities/investments etc.

6. INTERNAL AND EXTERNAL FACTORS

The Board decision in respect of dividend payout or retention of profits will, inter-alia, be based on the following factors:

Internal Factors:

- Profits earned during the year and profits available for distribution;

- ii. Operating cash flow of the Company;
- iii. Past performance and dividend history of the Company;
- iv. Return on capital invested;
- v. Earning Per Share;
- vi. Capital expenditure requirements for future expansion plans / projects of the Company;
- vii. Additional investments in subsidiaries / associates;
- viii. Resources required for acquisition of business / brand or joint venture formation;
- ix. Provisions for contingencies;
- x. Cost of borrowings and outstanding loans;
- xi. Any other factors as may be deemed fit by the Board.

External Factors:

- i. Economic environment;
- ii. Global conditions;
- iii. Statutory provisions;
- iv. Taxation and other regulatory matters.

7. CIRCUMSTANCES UNDER WHICH THE SHAREHOLDERS MAY OR MAY NOT EXPECT DIVIDEND

The Shareholders of the Company may or may not expect dividend under following circumstances:

- (i) Whenever the Company undertakes or proposes to undertake expansion project / plan which requires significant amount of capital investments;
- (ii) When the Company undertakes any acquisition or joint venture or restructuring;
- (iii) When the Company plans to utilise surplus cash for buy back of its securities;
- (iv) When the Company plans to build-up its reserves for future business plans;
- (v) Circumstances which affect the free cash flow position of the Company;
- (vi) In the event of absence of profits or inadequacy of profits;
- (vii) Such other factors as the Board may consider appropriate to declare or not to declare the dividend.

8. MANNER OF UTILIZATION OF RETAINED EARNINGS

The Board may retain its earnings in order to make better use of the available funds and increase the value of the stakeholders in the long run. The decision of utilization of the retained earnings of the Company will be based on the following factors:

- Strategic and long term plans of GACL;
- Diversification & expansion opportunities;
- Revamp of ageing plants and for achieving better energy efficiency;
- Non-fund based need of GACL, its Subsidiary and Joint Ventures which may require GACL to have healthy consolidated Balance Sheet;
- Any other criteria which the Board of GACL may consider appropriate.

9. PARAMETERS TO BE ADOPTED WITH REGARD TO VARIOUS CLASSES OF SHARES

The Company has presently issued only one class of equity shares with equal voting rights. The policy will be revisited at the time of issue of any new class of shares depending upon the nature and guidelines thereof.

10. POLICY REVIEW AND AMENDMENTS

This Policy will be subject to modification in accordance with the guidelines / clarifications as may be issued by the Regulatory Authorities. The Board of Directors may modify, add, delete or amend any of the provisions of this Policy.

MANAGEMENT DISCUSSION AND ANALYSIS

AN OVERVIEW OF INDIAN ECONOMY - INDUSTRY STRUCTURE AND DEVELOPMENTS:

Indian Economy during 2016-17

The Indian Economy has grown at the rate of 7.1% in the fiscal 2016-17 as compared to 7.6% in the previous year. GDP growth in fourth quarter of 2016-17 has been at 6.1% which was 7.9% in the same period of previous year. With a GDP at US\$ 2 trillion, India's economy ranks as the seventh largest in the World. As per OECD Economic Outlook Report, the economic growth is projected to remain strong and India will remain the fastest growing G20 economy in 2017-18. India is the fourth-fastest-growing economy with 7.2% projected growth. According to IMF World Economic Outlook, growth in India is projected to rebound to 7.2% in Financial Year 2017-18 and further to 7.7% in Financial Year 2018-19.

According to data released by the Central Statistics Office (CSO), the growth (Gross Value Added - GVA) in farm sectors during the fourth quarter of fiscal 2016-17 has accelerated to 5.2% as compared to 1.2% in the same period of previous year. While the manufacturing sector output in the fourth quarter slowed to 5.3% versus 12.7% in the same period of last year, the construction sector slipped into the negative territory.

The Financial Year 2016-17 was marked by two significant economic measures taken by the Government. The Government's demonetisation move to counter the shadow economy and promote cashless economy have increased financial inclusion and transparency in the system. This is expected to boost digital payments in the Country. The Government also passed a historical - Goods and Services Tax (GST) Act, which has been implemented from July 1, 2017. This will have a significant impact on the taxation structure and ease of doing business in the Country. The acceleration of structural reforms is bringing a new growth impetus.

The long-term growth prospective of the Indian Economy is positive due to its major structural reforms, young population, corresponding low dependency ratio, healthy savings and investments rates and increasing integration into the Global Economy.

INDIAN CHLOR-ALKALI INDUSTRY AT A GLANCE

According to India Chlor-Alkali Market Forecast & Opportunities, 2019, the market for Chlor-Alkali in India is projected to exhibit a Compound Annual Growth Rate (CAGR) of around 7%. The market is expected to witness high penetration rate in the Western and Northern regions of the Country.

There are 32 active Chlor-Alkali Units in India. The production of Caustic Soda during the Financial Year 2016-17 has been 30.18 Lakhs MTPA as against total capacity of approx. 37 Lakhs MTPA thus capacity utilization of 82%. The products of Chlor-Alkali industry are the basic raw materials for various industries like Alumina, Paper & Pulp, Soaps & Detergents,

Pharmaceuticals, Dyes, Pesticides, Water Treatment etc. The additional capacity expansion during the Financial Year 2016-17 was approx. 3.4 Lakhs MTPA in India mainly because of expansion of existing Plants (*Source: 39th Annual Report of AMAI*).

However, due to fall in global Ethylene Dichloride (EDC) price, Indian producers continued to import EDC - which is the key input in the production of Poly Vinyl Chloride (PVC), as also due to new Chlor-Alkali capacity addition and expansions of existing plants - Chlorine demand remain depressed; whereas supplies were in excess during the entire fiscal year. Depressed Chlorine demand & overall negative Chlorine value impacted overall capacity utilizations of Chlor-Alkali plants across the industry, which reduced domestic availability of Caustic Soda. Also, because of price rise in Caustic Soda globally, domestic Caustic Soda prices remain firm during the whole fiscal year.

THE CAUSTIC SODA MARKET SCENARIO

We are a multi-product Company, having more than 35 products in our basket, yet the major revenues are coming from Caustic Soda Group and therefore, market scenario of Caustic Soda and Chlorine market is of utmost important to us.

The installed capacity of Caustic Soda in the country is about 37 Lakhs MTPA as on 31.03.2017 as compared to 33.70 Lakhs MTPA as on 31.03.2016. The entire capacity in India is based on Membrane Cell Technology. The Membrane Cell process is energy efficient as the power requirement is much less and is in the range of 2300-2450 kwh/MT as compared to Mercury Cell where it is around 3150-3300 kwh/MT. GACL has the advantage of having its entire production from Membrane Cell. However, now all the medium & large scale Chlor-Alkali units have converted their plants to Membrane Cell Technology.

ABOUT GACL

The Company was established in 1973 and over a period of time, it has emerged as one of the largest producers of Caustic Soda in India with present installed production capacity of 4,29,050 MT of Caustic Soda as on 31st March, 2017 and enjoys the economies of scale. The Company has about 14% share in the domestic Chlor-Alkali market.

Your Company has implemented elaborate Environment Management System (EMS) Occupational Health & Safety (OH & S) plan and has embarked on continual improvement. Your Company has achieved ISO 9001:2008 (Quality Management System), ISO 14001:2004 (Environment Management System), BS/OHSAS 18001:2007 (Operational Health & Safety Management System), ISO 50000:2011 (Energy Management System) in its pursuit for excellence and sustainable growth.

The Quality Policy of the Company reflects its emphasis and commitments. Since inception, the Company has from time to time, expanded its operations in Chlor-Alkali Sector and also diversified into several higher end products, through forward &

backward integrations. GACL was the first Indian Company to replace the Mercury Cell Technology with environment friendly and energy efficient Membrane Cell Technology way back in the year 1989.

GACL has always ensured upgrading and adapting eco-friendly and green technologies while it ensured the capacity utilization of 95% in Caustic Soda during Financial Year 2016-17. Further, the Company has achieved optimum capacity utilization of more than 100% in some of the plants/products viz. Phosphoric Acid, Hydrogen Peroxide, Aluminium Chloride. Being a chemical manufacturing Company, GACL carries its passion for protecting the environment at every stage of its operations, keeping in view the interests of Customers, Shareholders, Employees, Society, Stakeholders and Mother Nature.

The Company's products basket comprises total 35 products including Caustic Soda, Chlorine, Hydrochloric Acid, Hydrogen, Chloromethanes, Potassium Hydroxide, Potassium Carbonate, Phosphoric Acid (85%), Hydrogen Peroxide, Sodium Chlorate, Stable Bleaching Powder, Poly Aluminium Chloride, Anhydrous Aluminium Chloride, Toluene based chemicals, Chlorinated Paraffin etc. The major revenues are derived from Caustic Soda Group and therefore, Caustic Soda and Chlorine market scenario has a wide impact on the Company's performance.

The Company's products are used by various industries viz. Textiles, Pulp & Paper, Soaps & Detergents, Alumina, Water Treatment, Petroleum, Plastics, Fertilizers, Pharmaceuticals, Agrochemicals, Plant Protection, Dyes & Dyes Intermediates, refrigeration gases, epoxy etc. and it has marked its presence across the globe even against stiff international competition by exporting its World class products viz. Caustic Soda Flakes, Caustic Soda Prills, Potassium Carbonate, Potassium Hydroxide Flakes, Hydrogen Peroxide, Liquid Chlorine, Phosphoric Acid, Aluminium Chloride, PAC, Hydrochloric Acid and CPW to Europe, West Asia, South East Asia, Africa, Middle East/Far East, SAARC countries etc.

Production of Caustic Soda by electrolysis process is highly power intensive and the Company devised a sustainable strategy to meet its growing energy demands. Besides 90 MW gas based Captive Co-generation Power Plant and participation in a 145 MW Joint Captive Gas based Power Plant of GIPCL, the Company has taken major initiative for green energy by setting up Wind Farms for a total installed capacity of 171.45 MW as on 31st March, 2017. The Company has also taken up 15 MW Solar Power Project for captive use and to meet the Solar Renewable Purchase Obligations. The Project is expected to be commenced during the Financial Year 2017-18.

BUSINESS, OPERATIONS & FINANCIAL PERFORMANCE

The total production of all the products of the Company has increased by 5.47% to 15,50,572 MT during the Financial Year 2016-17 from 14,70,197 MT in previous year. The production of Caustic Soda Lye, Chlorine Gas / Liquid, Hydrochloric Acid, Hydrogen Peroxide (100%), Poly Aluminium Chloride (18%), Aluminium Chloride, Potassium Carbonate, Phosphoric Acid

(85%), Stable Bleaching Powder, Sodium Chlorate and Chloro Toluene Products has increased during the Financial Year 2016-17 as compared to the previous year. However, the production of Caustic Soda Flakes / Prills, Chloromethanes, Potassium Hydroxide, KOH Flakes, CPW has decreased during the Financial Year 2016-17 mainly due to market conditions and stoppage of production facility of a job work contractor for CPW. The stoppage of production of Sodium Cyanide and Calcium Chloride in the previous year was continued during the year.

During the Financial Year 2016-17, the Company has achieved highest ever productions in Hydrochloric Acid (30%), Hydrogen Peroxide (100%) both at Baroda & Dahej Complexes and Aluminium Chloride, Poly Aluminium Chloride, Stable Bleaching Powder, Sodium Chlorate and Chlorotoluene Products at Dahej Complex.

During the Financial Year 2016-17, the Company has achieved highest ever sales in Caustic Soda Lye, Hydrochloric Acid (30%), Caustic Potash Lye, Hydrogen Peroxide (100%), Aluminium Chloride, Poly Aluminium Chloride, Benzyl Chloride, Benzyl Dehyde, Benzyl Alcohol, Sodium Chlorate and Stable Bleaching Powder.

During the year 2016-17, your Company has achieved highest ever Sales (including Excise Duty) of Rs.2,255.34 crores, as against Rs.2,178.62 crores in the previous year which indicates an increase of 3.52%.

The other operating income for the Financial Year 2016-17 was Rs.47.17 crores as compared to Rs.39.78 crores in the previous year. The other income during the Financial Year 2016-17 was increased to Rs.55.92 crores from Rs.46.22 crores in the previous year. The other income includes Rs.13.15 crores for receipt of Dividend and Rs.32.54 crores towards interest income.

The Earning Per Share has been achieved of Rs.41.95 per Share as on 31.03.2017, as compared to Rs.29.94 per Share as on 31.03.2016. Cash Earning Per Share has been achieved of Rs.67.09 as on 31.03.2017, as compared to Rs.50.40 per Share as on 31.03.2016. Book Value of Share has improved to Rs.450.84 per Share as on 31.03.2017 as compared to Rs.391.28 per Share as on 31.03.2016. The Return on Capital Employed is achieved at 8.91% as on 31.03.2017, as compared to 7.42% as on 31.03.2016. The Company has increased its total debts level to Rs.353.37 crores as on 31.03.2017 as compared to Rs.295.39 crores as on 31.03.2016, which resulted into increase in the Debt : Equity ratio to 0.09 : 1 as on 31.03.2017 as compared to 0.08 : 1 as on 31.03.2016. The Interest Coverage ratio has increased to 39.39 times as on 31.03.2017 as compared to 38.29 times as on 31.03.2016.

The overall Raw Material expenses have decreased to Rs.647.55 crores as compared to Rs.668.90 crores in the previous year, mainly due to decrease in procurement cost of various raw materials like Common Salt, Heavy Normal Paraffin, Aluminium Ingots, Barium Carbonate, Hydrated Lime, Toluene and Natural Gas etc. Electricity charges have decreased by 11.33% to Rs.413.44 crores in the Financial Year under review as compared to Rs.466.29 crores during the previous year,

mainly due to decrease in consumption of external purchased power during the Financial Year under review.

The cost of Fuel, Natural Gas and Water charges decreased to Rs.71.22 crores in the Financial Year under review from Rs.84.46 crores in the previous Financial Year, due to decrease in prices on Natural Gas. Employees' remuneration has increased to Rs.169.76 crores as compared to Rs.162.10 crores in previous year due to normal increment and provisioning requirement as per Ind AS 19. Depreciation and amortization expense has increased to Rs.110.92 crores in the year under review as compared to Rs.107.44 crores in the previous year, due to full year depreciation for the plants commissioned during the previous year and the year under review. Other expenses have increased by 14.82% to Rs.308.67 crores during the year under review from Rs.268.82 crores in the previous year. The Finance Costs have increased to Rs.12.83 crores from Rs.9.93 crores.

Gross Profit has increased to Rs.505.54 crores in Financial Year 2016-17 from Rs.380.07 crores in the previous year registering a growth of 33%. The Profit after finance costs but before depreciation and amortization (Cash Profit) has increased to Rs.492.70 crores in Financial Year 2016-17 from Rs.370.14 crores in the previous year. Your Company has achieved Profit Before Tax of Rs.381.78 crores for the Financial Year 2016-17 as compared to Rs.262.70 crores of the previous year registering a growth of 45%. The Profit After Tax for the Financial Year 2016-17 increased to Rs.308.10 crores as compared to Rs.219.89 crores of the previous year registering a growth of 40%.

At Consolidated Level, Gross Profit has increased by 32.80% to Rs.504.33 crores during the Financial Year 2016-17 from Rs.379.78 crores in previous year. Consolidated Profit Before Tax has increased by 45.03% to Rs.380.57 crores during the Financial Year 2016-17 from Rs.262.41 crores in previous year. Consolidated Profit After Tax has increased by 39.94% to Rs.307.30 crores during the Financial Year 2016-17 from Rs.219.60 crores in previous year.

RESEARCH AND DEVELOPMENT

The R&D activities are being carried out to develop a synergy between the present line of operations and futuristic need of organization. The prime focus has been on new product & process development, environment friendly technologies, waste utilization, process improvement, product quality and to achieve total customer satisfaction.

The process development work has been carried out in several areas which included the product based on Hydrogen Peroxide & waste generated from Phosphoric Acid Plant. We have also entered into a collaborative project on catalyst development with one of the premier research organization of our Country. The basic engineering package developed for Hydrazine Hydrate has been validated by an independent agency and the further work in terms of detailed engineering & commercialization of the process is already under progress.

The work also continued to monitor the process streams and quality of important raw materials in order to have better controls

on the process. The technical support to Operations, Marketing, Project & Process department was continuously extended which in turn resulted in to the fruitful benefits. The work on cooling water treatment including the technical support in terms of corrosion & microbiological growth monitoring was carried out successfully.

EXPANSION AND DIVERSIFICATION

The Company has taken up various projects for expanding its current product lines through debottlenecking of the existing plants and putting up additional capacities through new plants. Such projects include increasing the production capacity for Chloromethanes Plant from 110 TPD to 170 TPD as well as that for Potassium Hydroxide Plant from 60 TPD to 120 TPD, both at Vadodara Complex. The Potassium Hydroxide Plant became operational successfully during the Financial Year 2016-17 and the Chloromethanes Plant is expected to be operational during the Financial Year 2017-18. The Company is also expanding Hydrogen Peroxide capacity by putting another new 14,000 TPA plant at Dahej. The project is planned to go on stream in May, 2018. For gainful utilization of Chlorine, the Company has planned for establishment of a new 1,05,000 TPA Chloromethanes Plant and a new 33,870 TPA Phosphoric Acid Plant at Dahej Complex.

The Company also intends to put up a 15,000 MTPA Stable Bleaching Powder (SBP) Plant at an estimated cost of Rs. 22 crores and 16,500 TPA Anhydrous Aluminium Chloride (AAC) Plant at an estimated cost of Rs. 35 crores at Dahej Complex.

Further, the Company has increased capacity of Anhydrous Aluminium Chloride (AAC) Plant by installing four additional reactors during the Financial Year 2016-17 due to which the capacity of AAC Plant at Dahej has increased from 63 TPD to 72 TPD i.e. 14% increase.

The Company is successful in development of an indigenous technology in collaboration with Indian Institute of Chemical Technology (IICT) to manufacture Hydrazine Hydrate, an import substitute product, using Hydrogen Peroxide as the raw material. The basic engineering package of commercial plant to manufacture 8,000-10,000 TPA of Hydrazine Hydrate has been validated by an independent consultant. The plant will be put up at Dahej Complex.

The Company has formed a Joint Venture with National Aluminium Company Ltd. for putting up a new 800 TPD Caustic Soda Plant integrated with a 130 MW Coal based Power Plant at Dahej. The JV Company was incorporated in December, 2015 and the actions for implementing the project have been initiated. In order to gainfully utilize the Chlorine produced in this Plant, the Company is planning to establish a dedicated Chlorine Park wherein bulk Chlorine consuming units can be supplied Chlorine through pipeline.

A pilot project on converting waste liquid into a marketable product, Anhydrous Sodium Sulphate, is under implementation and expected to be operational during the Financial Year 2017-18.

In order to continue promoting Green technology, the Company had further taken up a Wind Farm Project for 14.7 MW during the year, which was commissioned on March 31, 2017 raising the installed Wind Power capacity further to 171.45 MW.

The Company has also taken up 15 MW Solar Power Project for captive use and to meet the Solar Renewable Purchase Obligations. The project is expected to be commissioned during the Financial Year 2017-18.

Upon successful completion of the above projects, the Company aims to increase its present top line of Rs.2,000 crores per annum to Rs.5,000 crores per annum by the year 2021.

SEGMENT-WISE OR PRODUCT-WISE PERFORMANCE

The operations of the Company are under one segment only i.e. Chemical Manufacturing. The total production of all the products of the Company has increased by 5.47% to 15,50,572 MT during the Financial Year 2016-17 from 14,70,197 MT in previous year.

Product-wise production details are given in back side of the cover page of this Annual Report. Further, the quantitative product-wise data relating to production and sales for last ten years is given in the Annual Report.

OPPORTUNITIES & THREATS, RISKS & CONCERNS

The strengths of the Company are economies of scale, state of the art eco-friendly technologies, extensive usage of renewable energy, integrated down stream plants, strong network for Marketing and Distribution, In-house Research and Development facilities, proximity to major raw material source and markets etc. Economical power supply has remained a major area of concern for the Company, however, during the year under review, the power cost has decreased as compared to previous year due to decrease in power rates from all sources and increase of power generation from Wind Farm.

The Company has followed a business plan for growth and sustained performance. The Company has continued to concentrate both on top and bottom lines. The increase in net sales by 3.29%, other operating income by 18.58% and other income by 20.99%, decrease in raw material cost (other than natural gas), insurance expense, net external electricity charges, utilities cost, packing material cost are the major factors contributing to the profitability of the Company, during the Financial Year 2016-17. However, due to increase in employee cost, depreciation and amortisation expense, stores, spares, job work / processing charges, other expenses and finance cost, the profitability of the Company for the year under review has been adversely affected.

The manpower of the Company with high morale and motivation always endeavours to bring better results. In next 2 to 3 years, considerable numbers of employees will retire from the services of the Company due to superannuation. The Company is in process of identifying succession plan and will implement the same in due course of time. Keeping in view, the current trends of Indian and global economy, the time ahead may prop-up newer hurdles. To overcome such hurdles, the Company has planned new projects during next 3 to 4 years, to diversify, add

new products, enlarge portfolio and expand its existing capacities. The Company is also considering various Chlorine / HCL based projects so that the production of Caustic Soda can be optimized. It will also enable us to consolidate and maintain our prime position in Chlor-Alkali and other integrated downstream products. Our continuous efforts to upgrade the technology has enabled us to optimize the cost of production and increase revenues. Our commitment to deliver quality products to the customers has ensured that our products are well accepted, both in India and abroad. The customers are assured of timely delivery of quality products through its well-established marketing network.

The Company is operating in a competitive market both in domestic and international sector. However, the increasing cost of power and utilities and impact of appreciation of USD on the cost of imported materials such as Rock Phosphate and Potassium Chloride etc. are the areas of concern. To augment its power requirement with eco-friendly renewable energy in 2016-17, the Company's total Wind Energy Generation Capacity has now gone up to 171.45 MW. Further, the Company has also taken actions to source power from IPPs on bilateral arrangements. The Company competes with manufacturers in China and Middle East, who have their own typical locational advantages with respect to energy cost and size of operations. Domestically, the import of several items is becoming cheaper with reduction in custom duty.

Globally for Chlor-Alkali Industry, Chlorine is the driving product whereas in India, Caustic Soda is the driving product. Hence, Indian Industry faces competition from cheaper imports with reduction in custom duty. To protect against unfair competition in products like Caustic Soda Lye / Flakes and Potassium Carbonate, the Indian manufacturers had approached the Designated Authority to impose Anti-dumping duty against such imports and Anti-dumping duty has been imposed on imports of these products from various countries.

All Chemical products generally pass through cyclic phase. While some products are in short supply, some others do not move satisfactorily. Owing to availability of 35 products in its basket, the products in short supplies provide some leverage against slow moving products.

The Company had only single source of procurements for the raw materials viz., Rock Phosphate from Jordan and Potassium Chloride from Canada. Efforts are on to search for other suppliers of the above materials of technical suitability for the designed plant at present, through domestic dealers / foreign suppliers.

Further, the Company has taken necessary actions to ensure that in the new Food Grade Phosphoric Acid Plant by designing the plant in such a way that it will be possible to use different types of Rock Phosphate.

Stoppage of Sodium Cyanide Plant

The Company had previous year, temporary shut down its Sodium Cyanide Plant due to non-availability of raw material viz. HCN, from the supplier. The supplier had stopped their ACN Plant to carry out Safety Audit of the plant. Since then, our plant

is under shutdown due to non-availability of raw material. Recently, the supplier has confirmed regarding closure of their plant operations permanently on the basis of Safety Audit findings and overall review of the plant. Thus, the Company has no other alternate source of HCN. Hence, the Company has decided to stop the plant permanently and dispose off the equipments of the Plant.

Mothball & Closure of Calcium Chloride Plant

The Calcium Chloride Plant of Vadodara Complex was incurring losses and in order to improve the profitability of the Company, the Company had in previous year, decided to close the said plant and mothball it for some time till the mode of disposal of the plant is decided. The Company was exploring the options to sell or otherwise dispose off the plant. This plant was of very small capacity and set up mainly to consume the excess Chlorine or Hydrochloric Acid. The Company has now decided to stop Calcium Chloride Plants at Vadodara and Dahej Complexes and equipments of the said Plant will be sold / disposed off.

GAIL Take or Pay Claim

For the Calendar Year 2014, the Company had received a demand notice of Rs.42.07 Crore from GAIL India Limited (GAIL) under "Take or Pay Clause" (Pay if not Taken Liability Clause) under the long term Gas Supply Agreement entered into between the Company and GAIL for its Dahej Complex. The Company had filed a petition before the Hon. High Court of Delhi under the Arbitration and Conciliation Act to protect its interest. The Hon. High Court of Delhi passed an order granting interim relief to the Company against invocation of LC and directed the appointment of Arbitrator for deciding the issue between the Company and GAIL. Pursuant to the said order, Dr. (Justice) Arijit Pasayat (Retd.) was appointed as Sole Arbitrator. The matter is pending with the Sole Arbitrator. The Company and GAIL are exploring possibilities to arrive at amicable settlement.

GAIL has proposed to settle the matter by accepting Rs.7.09 crores as one time settlement amount. However, since the Company had already requested GAIL to reduce quantity of gas by 33% in the year 2013 and the Company had also utilized more quantity of gas at its Vadodara Complex, the Company has proposed to settle the matter by paying Rs.4.21 crores to GAIL as against Rs.7.09 crores. The response from GAIL is still awaited.

ECB Loan

To part finance the cost of the expansion, the Company has from time to time availed following financial assistance by way of External Commercial Borrowing (ECB) instead of Rupee Term Loan with a view to minimize the interest outgo. These ECB Loans are not hedged, there being natural hedge available due to exports and considering low risk profile of the Company :

1. ECB loan of US \$ 20 Million equivalent to Rs.98.44 crores from HDFC Bank Limited in Financial Year 2012-13, carries interest rate of LIBOR plus 3.50% p.a. This loan is

secured by plant and machinery of 20,000 MT Sodium Chlorate Project at Dahej, Dist. Bharuch, Gujarat. It has to be repaid in 10 equal half yearly instalments from 14.08.2013.

2. ECB loan of US \$ 30 Million equivalent to Rs.190.20 crores from The Hongkong and Shanghai Banking Corporation Limited (HSBC Bank) in Financial Year 2015-16, carries interest rate of LIBOR plus 1.80% p.a. This loan is secured by plant and machinery of 31 MW Wind Farm Project at Dist. Rajkot and Kachchh, Gujarat and Potassium Hydroxide Plant at Ranoli, Dist. Vadodara, Gujarat. It has to be repaid in 10 equal half yearly instalments from 07.01.2018.
3. ECB loan of US \$ 20 Million equivalent to Rs.133.25 crores from ICICI Bank Limited in Financial Year 2016-17 carries interest rate of LIBOR plus 1.68% p.a. This loan is secured by plant and machinery of 14.7 MW Wind Farm Project at Dist. Porbandar, Gujarat, 915 Nos. Cell Elements at Ranoli, Dist. Vadodara, Gujarat and 440 Nos. Cell Elements at Dahej, Dist. Bharuch, Gujarat. It has to be repaid in 15 equal half yearly instalments from 10.09.2017.

RISK MANAGEMENT

The Company has constituted Internal Risk Management Committee comprising of Senior Executives of the Company who are heading respective departments viz. Finance, Manufacturing, Marketing, Purchase, Project, Safety, Information Technology, HR, Secretarial and Legal functions. The Executive Director (Finance) & CFO is the Chairman of the Internal Risk Management Committee. The Internal Risk Management Committee reports to the Managing Director and the risks identified by the said Committee along with proposed mitigation actions are discussed periodically with the Managing Director.

As per the Regulation 21 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), every Company (top 100 listed companies by market capitalization) is required to constitute a Risk Management Committee of Directors, which may also include the Senior Executives of the Company, however, the majority should be the Directors. The Chairperson of the Risk Management Committee shall be Member of the Board of Directors of the Company.

As a part of good Corporate Governance practice, the Board of Directors at its 353rd Meeting held on 11th February, 2016 has constituted the Risk Management Committee of Directors comprising of :

1. Shri J N Godbole, Chairman;
2. Shri Rajiv Lochan Jain; and
3. Shri P K Gera, IAS.

The said Risk Management Committee has been renamed as "Risk Management-cum-Safety Committee" w.e.f. 10th November, 2016 by the Board. The existing Internal Risk Management Committee of Senior Executives of the Company continues to function. Out of the various risks identified by the



Internal Risk Management Committee, the Audit Committee has identified certain critical risks, which are reviewed by the Risk Management-cum-Safety Committee, Audit Committee and by the Board of Directors on quarterly basis. A Report on the steps taken to mitigate those critical risks is also submitted to the Risk Management-cum-Safety Committee, Audit Committee and the Board of Directors.

INTERNAL CONTROL SYSTEM AND THEIR ADEQUACY

The Company has in place adequate internal financial controls with reference to financial statements. During the year, such controls were tested and no reportable material weakness in the design or operation was observed. As per the relevant provisions of the Companies Act, 2013, the Statutory Auditors have expressed their views on the adequacy of Internal Financial Control in their Audit Report.

OUTLOOK

The Company is manufacturing and marketing various products including Caustic Soda (Lye, Flakes & Prills), Liquid Chlorine, Hydrochloric Acid, Chloromethane, Hydrogen Peroxide, Caustic Potash (Lye & Flakes), Potassium Carbonate, Phosphoric Acid, Aluminium Chloride, Chlorinated Paraffin, Poly Aluminium Chloride, Chloro-Toluene and Sodium Chlorate etc.

Most of the plants are integrated in such a way that part of finished product of one plant is consumed as a raw material in other plant. The Company, thus, enjoys some leverage over its competitors due to its integration philosophy.

As a value addition to Hydrochloric Acid, the Company had commissioned Poly Aluminium Chloride (PAC) and is able to capture sizable domestic market for various grades of PAC, as a value addition to Hydrochloric Acid. The physical exports of PAC powder has also been increased, wherein realisation are promising.

Further, the Company has increased capacity of Anhydrous Aluminium Chloride (AAC) Plant by installing four additional reactors during the Financial Year 2016-17 due to which the capacity of AAC Plant at Dahej has increased from 63 TPD to 72 TPD i.e. 14% increase.

The Company has put up Stable Bleaching Powder facility as a value addition to Chlorine at Dahej Complex and the production is optimized and our product has been widely accepted among various segments like Water Treatment Plants, Disinfection, Aquaculture etc. across India. Further, the Company has successfully optimized its Sodium Chlorate Plant at Dahej, which finds applications primarily in Paper & Pulp Industry for "Elemental Chlorine Free Bleaching".

Gujarat is predominantly an industrial state, which contains a number of large, medium & small business units in the Chemical, Petrochemical, Plastics, Textile, Fertilizer & other Industries. As part of market development, we place emphasis on interaction with customers and develop new market for the products. Providing prompt after sales service, as & when required, is part of this strategy and this helps the Company to increase its volume especially for new products.

GACL is also exporting some of its products viz. Caustic Soda Flakes, Caustic Soda Prills, Potassium Carbonate, Potassium Hydroxide Flakes, Hydrogen Peroxide, Liquid Chlorine, Phosphoric Acid, Aluminium Chloride, PAC, Hydrochloric Acid and CPW to Europe, West Asia, South East Asia, Africa, Middle East/Far East, SAARC countries etc.

The Company is facing import threat and dumping of various products at low prices, which affects its capacity utilization, prices etc. and is pro-actively taking corrective action for imposition of Anti Dumping Duty within the WTO guidelines.

The Company has successfully continued to serve Eastern part of India and has executed supplies to NALCO, Orissa in tune of 27,775 MT. To remain competitive in distant markets, wherein transportation cost is a major constrain – a multi modal logistic option is explored. Accordingly, the Company has introduced Rail as well as Sea movement for bulk movement of Caustic Soda.

Supply of Caustic Soda Lye through Sea route to M/s. NALCO is also being explored & accordingly, all arrangements have been made to store required quantum of Caustic Soda Lye at the storage tank of GCPTCL, Dahej (hired by us for such transactions).

We have introduced Depot concept as Modinagar as our strategic location on Pan India basis. Accordingly, we have supplied 3,283 MT of Caustic Soda Lye to our consignment center at Modinagar through railways so as to efficiently cater to the demand of distantly located consumers. Various other stock points/consignment centers are proposed in the states like Uttar Pradesh, Maharashtra, Goa & Andhra Pradesh for making competitive presence in distant markets.

GACL has imported approximately 5,240 MT of Caustic Soda Lye and traded the same to domestic consumers during the Financial Year 2016-17.

FOREIGN EXCHANGE EARNINGS AND OUTGO

GACL has taken pro-active approach for various activities related to increase Export volume, revenue and the development of new export markets for existing & new products. Our foreign exchange earnings are sufficient to meet our obligation to repay ECB loans raised to reduce interest cost on various projects.

In the current Financial Year also, the Company targets at wider markets for export of various products with the help of Company's accreditation of IS/ISO 9001, 14001, 18001 & 50001 as also registration of Benzyl Alcohol with 'REACH'. The details of Foreign Exchange earnings and outgo are provided in Board's Report.

SAFETY & ENVIRONMENT

Our commitment to safety and preservation of environment has been encompassed in our "Quality, Health, Safety, Environment and Energy (QHSE En) Policy".

The Company has implemented elaborate Environment Management System (EMS), Occupational Health & Safety (OH & S) plan and has embarked on continual improvement. TUV

(India) Pvt. Ltd. has granted ISO 9001:2008, ISO 14001: 2004 and BS/OHSAS 18001: 2007 Integrated Management System certificates and Energy Management 50000 Certificate to the Company. The Company has continued its emphasis on safety awareness for its employees, contract labourers, customers handling our products and among communities in neighbourhood of our plants. The Company regularly organizes safety awareness programme for the employees. The Company has also initiated a unique concept of "Plant Healthiness Check-up" to identify and address weakness of the manufacturing facility.

The Company has also its Emergency Planning and Response (ERP) system to minimize effect of any Emergency like situations. Preparedness and response to this ERP is checked periodically by conducting Mock-drills. Adequate steps have been taken for pollution control, green belt development besides due compliance with statutory requirements for the protection of environment. In Vadodara Complex, green belt has been developed and maintained in 25 acres of land. The Company has also developed and maintained about 24000 sq. mts. green area including lawn gardens in the Plant area.

A recharge borewell has been constructed for harvesting rainwater to effectively recharge ground water table and raising the ground water level.

In both Complexes at Baroda and Dahej, large area has been covered by development and maintenance of green belt, landscaping, flora & fauna, rainwater harvesting and natural ponds. The Company has undertaken water conservation by channelizing Cooling Tower Water Spillage, treated sewage and drip irrigation. Nearly 15,476 nos. of trees have been planted and 17.51 acre Green Belt Garden developed till 31.03.2017 at Dahej Complex.

The canteen and garden waste is being converted into organic manure through in-house vermi-composting facility on regular basis at both the complexes.

The product Carbon Tetrachloride (CTC) comes under Ozone Depletion Substance (ODS) Rules, 2000 as per the guidelines of Montreal Protocol framed by Government of India. Under these Rules, production of CTC for non-feed stock application has been phased out while production of CTC only for feed stock application is continued.

A step further to its environment preservation philosophy and commitments, the Company is exploring possibility of recycling part of its liquid effluent stream, using ZLD (Zero Liquid Discharge) principle.

CORPORATE SOCIAL RESPONSIBILITY

During the year under review, your Company has continued to fulfill its Corporate Social Responsibilities to enhance Human Development Index (HDI) by undertaking various thematic activities in various areas. Promoting inclusive growth has been a priority for GACL from both a social and business perspective. The Company strives to make a difference to its customers, to the society and to the nation's development directly through its products and services, as well as through its development initiatives and community outreach.

The Company always comes forward with relevant aid to the society at large; one such initiative has been taken up to provide underground drainage network and Sewage Treatment Plant facility for entire Dahej Village which is in the close proximity of our Dahej Complex. Such an initiative by the Company was in line with our State Government's coveted dream of 'NIRMAL GUJARAT'.

Promoting education related activities are closely monitored by the Company. The Company has adopted 5 Government Primary Schools under the Uday Shaala Project at Chhotaudepur. Moreover, the Company is working intensively in field of educating and mainstreaming Children with special needs. The Company has adopted Government of Gujarat's Home for Mentally Deficient Children located at Karelibaug, Vadodara where destitute and orphan children with special needs are kept. As a part of CSR obligations, the Company has sponsored these children to Spandan School for mentally challenged for receiving special education and training necessary for mainstreaming them into the society. In addition to this, the Company has taken similar initiatives for the noble cause of helping children with learning Disabilities, Autism, Cerebral Palsy, Hearing Impairment, Down Syndrome by extending financial assistance to Akshar Trust, Medical Care Centre Trust (Kashiba Children's Hospital) of Vadodara and Osmosis Play Centre and Educational Games Library Trust of Bharuch. Similarly, the Company is also contributing for SEEDS Project of VIVEC (Shroffs Foundation Trust) to promote entrepreneurship among the young children from remote rural and tribal areas of the State. For promotion of preventive healthcare facilities, the Company has given financial assistance to Ramkrishna Paramhans Hospital (Shroffs Foundation Trust) for development of Neonatal Intensive Care unit, Paediatric Intensive Care Unit and Critical Care Unit at Kalali, Vadodara. In addition to this, the Company has also provided financial assistance in procurement of two invasive ventilators at Premdas Jalaram Hospital of Vadodara. Also in line with the Government's initiative of Swachh Bharat Mission, installation of Namma Toilets on platform no. 6 of Vadodara Railway Station is initiated. The Company has contributed for undertaking a phase wise research project for mapping Good CSR practices undertaken by Centre for Excellence in CSR of faculty of Social Works of the M. S. University of Vadodara.

Efforts to uphold the cultural legacy were also embarked upon to promote Art, Culture and Heritage by organizing a Heritage Walk during the Vadodara International Marathon Day Event. In addition to this, a unique initiative, Vadodara By Foot, is initiated with the objective to promote web enabled awareness generation regarding the heritage and culture of Vadodara city and making the information available on a single click supporting the government initiative to promote tourism and Digital India.

MATERIAL DEVELOPMENT IN HUMAN RESOURCES

The Human Resource function of the Company is guided by the spirit of Corporate Team Building with dedication towards strengthening the Company's systems thereby improving

efficiency and registering growth. All employees continue to have a healthy, cordial and harmonious approach in problem solving and in enhancing Company's value at all levels.

Human Resources at GACL is considered as a strategic business partner. The policies, procedures and practices are aligned to meet the organizational vision and mission.

The Human Resource department ensures that the employee diversity is advantageous and remains the strength of the Company. As a part of manpower and succession planning during the year 2016-17, the Company has taken all the efforts towards optimum utilization of human resources and total 50 (fifty) employees were recruited.

The Company has initiated various skill building and talent development programs to develop the potential of our employees. Total 168 training programs were conducted and there were 1,508 participants. We have initiated HR digitization processes through our In-house ERP system. This will help us to create a paper-less culture in our organization.

The Company has maintained the harmonious Industrial Relation and there was no industrial unrest, no complaint against sexual harassment or gender discrimination. There was adherence to all statutory HR compliances.

AWARDS AND RECOGNITIONS

The Company is a proud recipient of Award Tally-GHKC & GreEnv Contest – 2016-17 as winner for Vadodara Complex and also second runner up for Dahej Complex conducted by Baroda Productivity Council.

INFORMATION TECHNOLOGY

GACL considers the effective use of Information Technology (IT) and business analytics to be essential in raising productivity and achieving excellence in its business operations.

GACL believes that IT is an important enabler for integration of all activities, ensuring transaction efficiency, integrity, transparency and control. The Company has implanted its IT initiatives to corroborate its vision and business plan.

The Company has Enterprise Resource Planning (ERP) in place, which is backbone for its information base. The Vadodara and Dahej Complexes of the Company are connected through reliable WAN with solution implemented to get almost 100% uptime. A Decision Support System (DSS) is also implemented in addition to ERP, which helps top management in taking strategic and timely business decisions. Management has adopted a total transparent system of business with optimal use

of the state of art technologies and IT tools. It also provides information required by its business partners through website.

The Vadodara and Dahej Complexes are also connected through video conference facility and Daily Production Meetings (DPMs) are held regularly wherein all the members of Senior Management Team participates and discuss various points including Production, Marketing, Safety, Project implementation, HR / IR issues, etc.

The Company has its own mail server to achieve fast and reliable messaging solutions. Information about Company is available on its website www.gacl.com.

IMPLEMENTATION OF ERP-SAP

The Company had started its journey on the path of Information Technology in the year 1990-91 by setting up IT Department and developing home grown ERP including Decision Support System to meet its business needs. It has always been endeavour of GACL to keep the pace with technology advancement. Now in today's era with advance Corporate Governance and intense globalization of business, it had become imperative to keep pace with the changing era and adopt the progressive changes.

In view of the same, the Company decided for having ERP in place that matches the Global Standardization. In this direction Global Flagship ERP software "SAP" has been opted for implementation. The implementation of SAP would give us both tangible and non-tangible benefits on account of seamless integration and Business Process Re-Engineering. The SAP implementation is in the advanced stage.

NOTES TO THE STANDALONE FINANCIAL STATEMENTS

Notes forming part of the Financial Statements

1. GENERAL INFORMATION

Gujarat Alkalies and Chemicals Limited (the Company) is a multi-product chemical manufacturing Company, having 36 products in its basket and is one of the leading manufacturer of Caustic Soda Lye.

The financial statements have been prepared in accordance with Indian Accounting Standards (Ind AS) as notified under the Companies (Indian Accounting Standards) Rules, 2015.

Up to the year ended March 31, 2016, the Company prepared its financial statements in accordance with the requirements of the Standards notified under the Companies (Accounting Standards) Rules, 2014. These are the Company's first Ind AS adopted financial statements. The date of transition to Ind AS is April 1, 2015. Refer Note 2(19) for the details of first-time adoption exemptions availed by the Company. In accordance with Ind AS 101 First-time Adoption of Indian Accounting Standard, the Company has presented a reconciliation from the presentation of financial statements under Accounting Standards notified under the Companies (Accounting Standards) Rules, 2014 ("Previous GAAP") to Ind AS of Shareholders' equity as at March 31, 2016 and April 1, 2015 and of the comprehensive net income for the year ended March 31, 2016 and April 1, 2015.

(2) Basis of Preparation of financial statements

The financial statements have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

(3) Use of estimates

The preparation of the financial statements in conformity with Ind AS requires management to make estimates, judgements and assumptions. These estimates, judgements and assumptions affect the application of accounting policies and the reported amounts of assets and liabilities, the disclosures of contingent assets and liabilities at the date of the financial statements and

reported amounts of revenues and expenses during the period. Application of accounting policies that require critical accounting estimates involving complex and subjective judgements and the use of assumptions in these financial statements have been disclosed in notes below. Accounting estimates could change from period to period. Actual results could differ from these estimates. Appropriate changes in estimates are made as management becomes aware of changes in circumstances surrounding the estimates. Changes in estimates are reflected in the financial statements in the period in which changes are made and if material, then effects are disclosed in the notes to the financial statements.

(4) Revenue Recognition

(a) Sale of Goods :

Revenue from the sale of Goods is recognised when the goods are delivered and titles have been passed, at which time all the following conditions are satisfied:

- the Company has transferred to the buyer the significant risks and rewards of ownership of the goods;
- the Company retains neither continuing managerial involvement to the degree usually associated with ownership nor effective control over the goods sold;
- the amount of revenue can be measured reliably;
- it is probable that the economic benefits associated with the transaction will flow to the Company; and
- the costs incurred or to be incurred in respect of the transaction can be measured reliably.

Sales are net of discounts, sales tax and value added tax but includes handling charges and packing charges. The Sales figure is grossed up to include Excise duty collected on sales.

(b) Dividend and interest income :

Dividend income from investments is recognised when the shareholder's right to receive the payment has been established.

Interest income from a financial asset is recognised when it is probable that the economic benefits will flow to the Company and the amount of income can be measured reliably. Interest income is accrued on time basis, by reference to the principal outstanding and at the effective interest rate applicable.

(c) Other Operating Income and Other Income :

Revenue with respect to Other Operating Income and Other Income including insurance and other claims are recognised when a reasonable certainty as to its realisation exists.

(5) Leasing

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership to the lessee. All other leases are classified as operating leases.

When acquired, finance leases are capitalised at fair value or present value of Minimum Lease payments at the inception of the lease, whichever is lower. Lease payments under operating leases are recognised as an expense on a straight line basis in net profit in the Statement of Profit and Loss over the lease term.

(6) Foreign Currencies

(a) Functional Currency :

The functional currency of the Company is the Indian rupee. These financial statements are presented in Indian rupees (rounded off to lakhs).

(b) Transactions and translations :

In preparing the financial statements, transactions in currencies other than the Company's functional currency (foreign currencies) are recognised at the rates of exchange prevailing at the dates of the transactions. At the end of each reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences on monetary items are recognised in profit or loss in the period in which they arise except for exchange differences on foreign currency borrowings relating to assets under construction for future productive use, which are included in the cost of those assets when they are regarded as an adjustment to interest costs on those foreign currency borrowings.

(7) Borrowing Costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

Borrowing costs consist of interest and other costs that the Company incurs in connection with the borrowing of funds. Borrowing cost also includes exchange differences to the extent regarded as an adjustment to the borrowing costs.

(8) Employee Benefits

(a) Short term Employee Benefits :

All employee benefits payable wholly within twelve months of rendering the services are classified as short term employee benefits. Benefits such as salaries, wages etc. and the expected cost of Bonus, Ex-gratia, Leave Travel Allowance, Reimbursement of Medical Expenses, Personal Accident Policy, Deposit Linked Insurance Policy are recognised in the period in which the employee renders the related services.

(b) Post-Employment Benefits :

(i) Defined Contribution Plan :

The Company's contribution paid / payable during the year to Provident Fund, Superannuation Fund and other welfare funds are considered as defined contribution plans. The Contribution paid / payable under these plans are recognised in the Statement of Profit and Loss during the period in which the employee renders the services.

(ii) Defined Benefit Plans :

The Gratuity Scheme managed by Life Insurance Corporation of India through a Trust is considered as defined benefit plan. The present value of the obligation is determined based on actuarial valuation using the Projected Unit Credit Method.

Actuarial gains and losses are recognised immediately in the Statement of Profit and Loss and Other Comprehensive Income.

The fair value of the plan assets is reduced from the gross obligation under the defined benefit plan to recognise the obligation on net basis.

Gains or losses on the curtailment or settlement of any defined benefit plan are recognised when the curtailment or settlement occurs.

(iii) Long term Employee Benefits :

The obligation for long term employee benefits such as long term compensated absences, long service awards, etc. is recognised in the same manner as in the case of defined benefit plans as mentioned in (b) (ii) above except that the actuarial gains and losses are recognised immediately in the Statement of Profit and Loss.

(9) Income Taxes

Income tax expense represents the sum of the tax currently payable and deferred tax.

(a) Current Tax :

The tax currently payable is based on taxable profit for the year. Taxable profit differs from 'Profit Before

Tax' as reported in the Statement of Profit and Loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Company's current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

(b) Deferred Tax :

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit. In addition, deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax liabilities and assets are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realised, based on tax rates and tax laws that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Company expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

(c) Current and Deferred Tax for the Year :

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in Other Comprehensive Income or directly in equity, in which case, the current and deferred tax are also recognised in Other Comprehensive Income or directly in equity respectively.

(10) Property, Plant and Equipment

Freehold land is carried at historical cost. All other items of property, plant and equipment are stated at historical cost less depreciation.

Property, plant and equipment are stated at cost, less accumulated depreciation and impairment, if any. Costs directly attributable to acquisition are capitalised until the property, plant and equipment are ready for use, as intended by management. The Company depreciates property, plant and equipment over their estimated useful lives using the straight line method. The estimated useful lives of the assets are as follows:

Depreciation is recognised so as to write off the cost of assets (other than freehold land and properties under construction) less their residual values over their useful lives, using the straight-line method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis. The useful life as prescribed under Schedule II of the Companies Act have been followed except in respect of the following categories of assets, in whose case the life of the assets has been assessed as under based on technical advice, taking into account the nature of the asset, the estimated usage of the asset, the operating condition of the asset, past history of replacement, anticipated technological changes, manufacturers warranties and maintenance support, etc.:

- Remembraning of Membrane cell elements-4 years
- Recoating of Anode and Cathode membrane cell elements-8 years
- Leasehold land and equipment is amortised over the duration of the lease.

Advances paid towards the acquisition of property, plant and equipment outstanding at each Balance Sheet date is classified as capital advances under Other Non-Current Assets and the cost of the assets not put to use before such date are disclosed under 'Capital work-in-progress'. Subsequent expenditures relating to property, plant and equipment is capitalised only when it is probable that future economic benefits associated with these will flow to the Company and the cost of the item can be measured reliably. Repairs and maintenance costs are recognized in net profit in the Statement of Profit and Loss when incurred. The cost and related accumulated depreciation are eliminated from the financial statements upon sale or retirement of the asset and the resultant gains or losses are recognised in the Statement of Profit and Loss. Assets to be disposed off are reported at the lower of the carrying value or the fair value less cost to sell.

For transition to Ind AS, the Company has elected to continue with the carrying value of all of its property, plant and equipment recognised as of April 1, 2015 (transition

NOTES TO THE STANDALONE FINANCIAL STATEMENTS

date) measured as per the previous GAAP and considered that carrying value as its deemed cost as of the transition date.

(11) Intangible Assets

Intangible Assets acquired separately :

Intangible assets with finite useful lives that are acquired separately are carried at cost less accumulated amortisation and accumulated impairment losses. Amortisation is recognised on a straight-line basis over their estimated useful lives from the date they are available for use. The estimated useful life and amortisation method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis. Intangible assets with indefinite useful lives that are acquired separately are carried at cost less accumulated impairment losses.

Useful Lives of Intangible Assets :

(12) Impairment of Tangible and Intangible Assets other than Goodwill

Intangible assets and property, plant and equipment are evaluated for recoverability whenever events or changes in circumstances indicate that their carrying amounts may not be recoverable. For the purpose of impairment testing, the recoverable amount (i.e. the higher of the fair value less cost to sell and the value-in-use) is determined on an individual asset basis unless the asset does not generate cash flows that are largely independent of those from other assets. In such cases, the recoverable amount is determined for the cash generating unit to which the asset belongs.

If such assets are considered to be impaired, the impairment is recognized in the Statement of Profit and Loss and is measured by the amount by which the carrying value of the assets exceeds the estimated recoverable amount of the asset. An impairment loss is reversed in the Statement of Profit and Loss if there has been a change in the estimates used to determine the recoverable amount. The carrying amount of the asset is increased to its revised recoverable amount, provided that this amount does not exceed the carrying amount that would have been determined (net of any accumulated amortization or depreciation) had no impairment loss been recognized for the asset in prior years.

(13) Inventories

Inventories are stated at the lower of cost and net realisable value after providing for obsolescence. Costs of inventories are determined on weighted average basis. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and

costs necessary to make the sale. Cost of inventories comprises of cost of purchase, cost of conversion and other costs including manufacturing overheads incurred in bringing them to their respective present location and condition.

(14) Provisions

Provisions are recognised when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that the Company will be required to settle the obligation, and a reliable estimate can be made of the amount of the obligation.

(15) Financial Instruments

The Company determines the classification of its financial assets and liabilities at initial recognition. The classification depends on the Company's business model for managing the financial assets and the contractual terms of the cash flows.

Initial Recognition :

The Company recognizes financial assets and financial liabilities when it becomes a party to the contractual provisions of the instrument. All financial assets and liabilities are recognized at fair value on initial recognition, except for trade receivables which are initially measured at transaction price. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities that are not at fair value through profit or loss, are added to the fair value on initial recognition. Regular way purchase and sale of financial assets are accounted for at trade date.

Subsequent Measurement :

(a) Non-derivative financial instruments :

(i) Cash and Cash equivalents :

The Company considers all highly liquid financial instruments, which are readily convertible into known amounts of cash that are subject to an insignificant risk of change in value and having original maturities of three months or less from the date of purchase, to be cash equivalents. Cash and cash equivalents consists of balances with banks which are unrestricted for withdrawal and usage.

(ii) Financial assets carried at amortised cost :

A financial asset is subsequently measured at amortised cost if it is held within a business model whose objective is to hold the asset in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

(iii) Financial assets at fair value through Other Comprehensive Income (FVTOCI) :

A financial asset is subsequently measured at fair value through Other Comprehensive

Income if it is held within a business model whose objective is achieved by both collecting contractual cash flows and selling financial assets and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding. The Company has made an irrevocable election for its investments which are classified as equity instruments to present the subsequent changes in fair value in Other Comprehensive Income based on its business model.

(iv) Financial assets at fair value through profit or loss (FVTPL) :

A financial asset which is not classified in any of the above categories are subsequently fair valued through profit or loss.

(v) Investment in Joint Venture :

A joint venture is a joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint arrangement. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require unanimous consent of the parties sharing control.

The Company accounts for its investment in joint venture at cost.

(vi) Financial liabilities :

Financial liabilities are subsequently carried at amortized cost using the effective interest method. For trade and other payables maturing within one year from the Balance Sheet date, the carrying amounts approximate fair value due to the short maturity of these instruments.

(b) Share capital :

Ordinary Shares

Ordinary shares are classified as equity. Incremental costs directly attributable to the issuance of new ordinary shares are recognized as a deduction from equity, net of any tax effects.

Derecognition of financial instruments :

The Company derecognizes a financial asset when the contractual rights to the cash flows from the financial asset expire or it transfers the financial asset and the transfer qualifies for derecognition under Ind AS 109. A financial liability (or a part of a financial liability) is derecognized from the Company's Balance Sheet when the obligation specified in the contract is discharged or cancelled or expires.

(16) Fair value of financial instruments

In determining the fair value of its financial instruments, the Company uses a variety of methods and assumptions that are based on market conditions and risks existing at each reporting date. The methods used to determine fair value include available quoted market prices and valuation reports from independent valuers. All methods of assessing fair value result in general approximation of value and such value may never actually be realized.

(17) Impairment of Financial Assets

The Company recognizes loss allowances using the Expected Credit Loss (ECL) model for the financial assets which are not fair valued through profit or loss. Loss allowance for trade receivables with no significant financing component is measured at an amount equal to lifetime ECL. For all other financial assets, expected credit losses are measured at an amount equal to the 12-month ECL, unless there has been a significant increase in credit risk from initial recognition in which case those are measured at lifetime ECL. The amount of expected credit losses (or reversal) that is required to adjust the loss allowance at the reporting date to the amount that is required to be recognised is recognised as an impairment gain or loss in profit or loss.

(18) Earnings per share

Basic earnings per share are computed by dividing the profit or loss attributable to equity shareholders of the Company by the weighted average number of equity shares outstanding during the period. The Company did not have any potentially dilutive securities in any of the period presented.

(19) First-time adoption-mandatory exceptions and optional exemptions

Overall Principle :

The Company has prepared the opening Balance Sheet as per Ind AS as of April 1, 2015 (the transition date) by recognising all assets and liabilities whose recognition is required by Ind AS, not recognising items of assets or liabilities which are not permitted by Ind AS, by reclassifying items from previous GAAP to Ind AS as required under Ind AS, and applying Ind AS in measurement of recognised assets and liabilities. However, this principle is subject to the certain exceptions and certain optional exemptions availed by the Company as detailed below.

Classification of Debt Instruments :

The Company has determined the classification of debt instruments in terms of whether they meet the amortised cost criteria or the FVTOCI criteria based on the facts and circumstances that existed as of the transition date.

Impairment of financial assets :

The Company has applied the impairment requirements of Ind AS 109 retrospectively; however, as permitted by

Ind AS 101, it has used reasonable and supportable information that is available without undue cost or effort to determine the credit risk at the date that financial instruments were initially recognised in order to compare it with the credit risk at the transition date. Further, the Company has not undertaken an exhaustive search for information when determining, at the date of transition to Ind AS, whether there have been significant increases in credit risk since initial recognition, as permitted by Ind AS 101.

Deemed cost for property, plant and equipment and intangible assets :

The Company has elected to continue with the carrying value of all of its plant and equipment and intangible assets recognised as of April 1, 2015 (transition date) measured as per the previous GAAP and use that carrying value as its deemed cost as of the transition date.

Equity investments at FVTOCI :

The Company has designated investment in equity instruments as at FVTOCI on the basis of facts and circumstances that existed at the transition date.

(20) Recent accounting pronouncements

(i) Standards issued but not yet effective :

In March, 2017, the Ministry of Corporate Affairs issued the Companies (Indian Accounting Standards) (Amendments) Rules, 2017, notifying amendment to Ind AS 7, 'Statement of cash flows'. This amendment is in accordance with the recent amendment made by International Accounting Standards Board (IASB) to IAS 7, 'Statement of Cashflows' and IFRS 2. This amendment is applicable to the Company from April 1, 2017.

(ii) Amendment of Ind AS 7 :

The amendment to Ind AS 7 requires the entities to provide disclosures that enable users of financial statements to evaluate changes in liabilities arising from financing activities, including both changes arising from cash flows and non-cash changes, suggesting inclusion of a reconciliation between the opening and closing balances in the balance sheet for liabilities arising from financing activities, to meet the disclosure requirement.

The Company is evaluating the requirements of the amendment and the effect on the financial statements is being evaluated.

(21) Critical judgements in applying accounting policies

The following are the critical judgements, apart from those involving estimations that the management have made in the process of applying the Company's accounting policies and that have the most significant effect on the amounts recognized in the financial statements. Actual results may differ from these estimates. These estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to the accounting estimates in the period

in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Useful lives and residual value of property, plant and equipment :

The Company reviews the useful life and residual value of property, plant and equipment at the end of each reporting period. This reassessment may result in change in depreciation expense in future periods.

Allowance for expected credit losses :

Note-12 describes the use of practical expedient by computing the expected credit loss allowance for trade receivables based on provision matrix. The expected credit allowance is based on the aging of the days receivables which are past due and the rates derived based on past history of defaults in the provision matrix.

Dismantling cost of property, plant and equipment :

Note-3 describes assets retirement obligation on estimate basis for property, plant and equipment. The management estimates dismantling cost considering size of the asset and its useful life in line with industry practices.

Stores and spares inventories :

The Company's manufacturing process is continuous and highly mechanic with wide range of different types of plant and machineries. The Company keeps stores and spares as standby to continue the operations without any disruption. Considering wide range of stores and spares and long lead time for procurement of it and based on criticality of spares, the Company believes that net realizable value would be more than cost.

Fair value of investments :

The Company has invested in the equity instruments of various companies. However, the percentage of shareholding of the Company in such investee companies is very low and hence, it has not been provided with future projections including projected profit and loss account by those investee companies. Hence, the valuation exercise carried out by the Company with the help of an independent valuer has estimated fair value at each reporting period based on available historical annual reports and other information in the public domain.

Income taxes :

Significant judgements are involved in determining the provision for income taxes, including amount expected to be paid/recovered for uncertain tax positions.

Contingent liability judgement :

Note-42 describes claims against the Company not acknowledged as debt. It includes certain penalties and charges payable to Government agency although as per the contracts, the Management, based on past experience, believes that the penalties and charges are negotiable and not certain and accordingly it is not considered as an obligation as at balance-sheet date and disclosed as contingent liabilities.

The Company manages its capital structure and makes adjustments to it in light of changes in economic conditions and the requirements of the financial covenants. The Company monitors capital by computing the above ratios on an annual basis and ensuring that the same is in Compliance with the requirements of the Financial Covenants.

36.3 Financial Risk Management objectives

The Company's Corporate Treasury Function provides services to the business, co-ordinates access to domestic and international financial markets, monitors and manages the financial risks relating to the operations of the Company through internal risk reports which analyse exposures by degree and magnitude of risks. These risks include market risk (including currency risk, interest rate risk and other price risk), credit risk and liquidity risk.

Compliance with policies and exposure limits is reviewed internally on a continuous basis. The Corporate Treasury does not enter into any trade financial instruments, including derivative financial instruments and relies on natural hedge.

The Corporate Treasury Function monitors risks and policies implemented to mitigate risk exposures on a periodical basis.

36.4 Market Risk

The Company's activities expose it primarily to the financial risks of changes in foreign currency exchange rates and interest rates. The Company currently has not hedged any External Commercial Borrowings (ECBs). The Company performs an analysis of the impact of not hedging its ECBs. This has been done by comparing the actual cash outflows related to ECBs under current unhedged conditions in the past vis-a-vis the scenario of complete hedging of individual ECB on the disbursement day through quotes provided by the banks. Further, the Company parks its earnings in foreign currency in Exchange Earners Foreign Currency (EEFC) account and discharges its obligations in case of foreign currency loans out of the said account.

NOTES TO THE STANDALONE FINANCIAL STATEMENTS

The Company's investments in listed and non-listed equity securities are susceptible to price risk arising from uncertainties about future value of the investment securities. The Company's non-current investment in equity shares are strategic investments and hence are considered as Fair Value through Other Comprehensive Income. The company's Board of Directors reviews and approves all equity investment decisions.

36.5 Foreign currency risk management

The Company undertakes transactions denominated in foreign currencies; consequently, exposures to exchange rate fluctuations arise. Exchange rate exposures are managed within approved policy parameters. Further, the Company parks its earnings in foreign currency in Exchange Earners Foreign Currency (EEFC) account and discharges its obligations in case of foreign currency loans out of the said account.

36.6 Interest rate risk management

The Company is exposed to interest rate risk because the Company borrows funds at floating interest rates. The risk is managed by the Company by monitoring the exchange rate on regular basis and also parking the export proceeds in the EEFC account which also provides a natural hedge for the outflows in foreign currency. Further, the Company performs an impact analysis of not hedging its ECBs. This has been done by comparing the actual cash outflows related to ECBs under current unhedged conditions in the past vis-a-vis the scenario of complete hedging of individual ECB on the disbursement day through quotes provided by the banks.

Interest rate sensitivity analysis

The sensitivity analysis below have been determined based on the exposure to interest rates for instruments at the end of the reporting period. For floating rate liabilities, the analysis is prepared assuming the amount of the liability outstanding at the end of the reporting period was outstanding for the whole year.

If the interest rates had been 50 basis points higher/lower and all other variables were held constant, the Company's profit before tax for the year ended would be impacted to the extent of Rs.169 Lakhs (Rs. 127 lakhs for the year 2015-16).

36.7 Credit Risk Management

Credit risk refers to the risk that the counterparty will default on its contractual obligations resulting in financial loss to the Company. The Company is operating through network of dealers based at different locations. In order to ensure the security of receivables, the Marketing Department computes an exposure ratio for every dealer based on his past turnover, track record, etc. The same is overseen and approved by the Board. Further, the Company also collects bank guarantees / security deposits from the respective dealers. Regular monitoring of the receivables is undertaken by the Marketing Department and in case the limits are exceeded, an auto lock system is in place in the existing ERP of the Company to stop further supplies to the concerned dealer till the amount outstanding is recovered. In case of new customers, the goods are supplied only against advance receipts. For the export made by the Company, the sales are backed by letters of credit or advance receipts. The internal risk management committee of the Company meets regularly to discuss the dealers and credit risks, measures taken to address them and the status and level of risk after the measures taken.

Domestic trade receivables are secured to the extent of interest free security deposits and bank guarantees received from the customers amounting to Rs.4,520.08 lakhs, Rs.4,159.64 lakhs and Rs.4,064.64 lakhs as at 31st March, 2017, 31st March, 2016 and 1st April, 2015 respectively. Export sales are fully secured through letters of credit or against advance receipts. (refer Note No. 12 for Trade Receivables outstanding).

36.8 Liquidity risk management

Ultimate responsibility for liquidity risk management rests with the Board of Directors, which has established an appropriate liquidity risk management framework for the management of the Company's short-term, medium-term and long-term funding and liquidity management requirements. The Company manages its funds mainly from internal accruals. The liquidity risk is managed by maintaining adequate reserves and banking facilities, by continuously monitoring forecast and actual cash flows and by matching the maturity profiles of financial assets and liabilities.

It also include impact on account of effective interest on borrowings and certain pre-operative expenses viz. liquidated damages / penalty, etc. capitalized under previous GAAP, taken to the Statement of profit and loss under Ind AS.
- Under Ind AS, expected life time credit provision is made on trade receivables. Under previous GAAP, the provision for doubtful debts was made using ageing analysis and an individual assessment of recoverability.
- Under Ind AS, re-measurements, i.e. actuarial gains and losses included in the net gratuity expense on the net defined liability are recognised in other comprehensive income instead of profit or loss.
- Deferred tax adjustments are on account of above Ind AS adjustments.
- Under Ind AS, other comprehensive income adjustments are on account of fair valuation of non-current investments and actuarial gain / loss on defined benefit plan – gratuity, net of tax effect.

Report on the Consolidated Ind AS Financial Statements

We have audited the accompanying consolidated Ind AS financial statements of Gujarat Alkalies and Chemicals Limited (hereinafter referred to as "the Parent") and its Joint Venture company, comprising the Consolidated Balance Sheet as at 31st March, 2017, the Consolidated Statement of Profit and Loss including other comprehensive income, the Consolidated Cash Flow Statement, the Consolidated Statement of Changes in Equity, for the year then ended, and a summary of the significant accounting policies and other explanatory information (hereinafter referred to as "the consolidated Ind AS financial statements").

- (b) The comparative financial information for the year ended 31st March, 2016 in respect of one Joint Venture included in this consolidated Ind AS financial statements prepared in accordance with the Ind AS have been audited by other auditors and have been relied upon by us.

- (c) The comparative financial information of the Group and Joint Venture for the year ended 31st March, 2016 and the transition date opening balance sheet as at 1st April, 2015 included in these consolidated Ind AS financial statements have been prepared to comply with Ind AS. Adjustments made to the consolidated financial information prepared in accordance with the Companies (Accounting Standards) Rules, 2006 to comply with Ind AS have been audited by us.

Our opinion on the consolidated Ind AS financial statements above and our report on Other Legal and Regulatory Requirements below, is not modified in respect of the above matters with respect to our reliance on the work done and the report of other auditor.

Report on Other Legal and Regulatory Requirements

- In our opinion, proper books of account as required by law relating to preparation of the aforesaid consolidated Ind AS financial statements have been kept so far as it appears from our examination of those books, returns and the reports of the other auditors.
- The Consolidated Balance Sheet, the Consolidated Statement of Profit and Loss (including Other Comprehensive Income), the Consolidated Cash Flow Statement and Consolidated Statement of Changes in Equity dealt with by this Report are in agreement with the relevant books of account maintained for the purpose of preparation of the consolidated Ind AS financial statements.

NOTES TO THE CONSOLIDATED FINANCIAL STATEMENTS

Notes forming part of the Financial Statements

1. GENERAL INFORMATION

Gujarat Alkalies and Chemicals Limited (the Group) is a multi-product chemical manufacturing Group, having 36 products in its basket and is one of the leading manufacturer of Caustic Soda Lye.

The Group having CIN L24110GJ1973PLC002247 is a public limited Group incorporated and domiciled in India and has its Registered Office at P.O.: Petrochemicals – 391 346, District Vadodara, Gujarat, India. The equity shares of the Group are listed on the BSE Limited and National Stock Exchange of India Limited.

The financial statements are approved for issue by the Group's Board of Directors on 26th May, 2017.

2. SIGNIFICANT ACCOUNTING POLICIES

(1) Statement of Compliance

The financial statements have been prepared in accordance with Indian Accounting Standards (Ind AS) as notified under the Companies (Indian Accounting Standards) Rules, 2015.

Upto the year ended March 31, 2016, the Group prepared its financial statements in accordance with the requirements of the Standards notified under the Companies (Accounting Standards) Rules, 2014. These are the Group's first Ind AS adopted financial statements. The date of transition to Ind AS is April 1, 2015. Refer Note 2(19) for the details of first-time adoption exemptions availed by the Group. In accordance with Ind AS 101 First-time Adoption of Indian Accounting Standard, the Group has presented a reconciliation from the presentation of financial statements under Accounting Standards notified under the Companies (Accounting Standards) Rules, 2014 ("Previous GAAP") to Ind AS of Shareholders' equity as at March 31, 2016 and April 1, 2015 and of the comprehensive net income for the year ended March 31, 2016 and April 1, 2015.

(2) Basis of Preparation of financial statements

The financial statements have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

(3) Principles of consolidation of Joint Venture

Interest in joint ventures are accounted for using equity method, after initially recognised at cost in the consolidated balance sheet.

(4) Use of estimates

The preparation of the financial statements in conformity

with Ind AS requires management to make estimates, judgements and assumptions. These estimates, judgements and assumptions affect the application of accounting policies and the reported amounts of assets and liabilities, the disclosures of contingent assets and liabilities at the date of the financial statements and reported amounts of revenues and expenses during the period. Application of accounting policies that require critical accounting estimates involving complex and subjective judgements and the use of assumptions in these financial statements have been disclosed in notes below. Accounting estimates could change from period to period. Actual results could differ from these estimates. Appropriate changes in estimates are made as management becomes aware of changes in circumstances surrounding the estimates. Changes in estimates are reflected in the financial statements in the period in which changes are made and if material, then effects are disclosed in the notes to the financial statements.

(5) Revenue Recognition

(a) Sale of Goods :

Revenue from the sale of Goods is recognised when the goods are delivered and titles have been passed, at which time all the following conditions are satisfied:

- the Group has transferred to the buyer the significant risks and rewards of ownership of the goods;
- the Group retains neither continuing managerial involvement to the degree usually associated with ownership nor effective control over the goods sold;
- the amount of revenue can be measured reliably;
- it is probable that the economic benefits associated with the transaction will flow to the Group; and
- the costs incurred or to be incurred in respect of the transaction can be measured reliably.

Sales are net of discounts, sales tax and value added tax but includes handling charges and packing charges. The Sales figure is grossed up to include Excise duty collected on sales.

(b) Dividend and Interest Income :

Dividend income from investments is recognised when the shareholder's right to receive the payment has been established.

Interest income from a financial asset is recognised

when it is probable that the economic benefits will flow to the Group and the amount of income can be measured reliably. Interest income is accrued on time basis, by reference to the principal outstanding and at the effective interest rate applicable.

(c) Other Operating Income and Other Income :

Revenue with respect to Other Operating Income and Other Income including insurance and other claims are recognised when a reasonable certainty as to its realisation exists.

(6) Leasing

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership to the lessee. All other leases are classified as operating leases.

When acquired, finance leases are capitalised at fair value or present value of Minimum Lease payments at the inception of the lease, whichever is lower. Lease payments under operating leases are recognised as an expense on a straight line basis in net profit in the Statement of Profit and Loss over the lease term.

(7) Foreign Currencies

(a) Functional Currency :

The functional currency of the Group is the Indian rupee. These financial statements are presented in Indian rupees (rounded off to lakhs).

(b) Transactions and translations :

In preparing the financial statements, transactions in currencies other than the Group's functional currency (foreign currencies) are recognised at the rates of exchange prevailing at the dates of the transactions. At the end of each reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences on monetary items are recognised in profit or loss in the period in which they arise except for exchange differences on foreign currency borrowings relating to assets under construction for future productive use, which are included in the cost of those assets when they are regarded as an adjustment to interest costs on those foreign currency borrowings.

(8) Borrowing Costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time

to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

Borrowing costs consist of interest and other costs that the Group incurs in connection with the borrowing of funds. Borrowing cost also includes exchange differences to the extent regarded as an adjustment to the borrowing costs.

(9) Employee Benefits

(a) Short term Employee Benefits :

All employee benefits payable wholly within twelve months of rendering the services are classified as short term employee benefits. Benefits such as salaries, wages etc. and the expected cost of Bonus, Ex-gratia, Leave Travel Allowance, Reimbursement of Medical Expenses, Personal Accident Policy, Deposit Linked Insurance Policy are recognised in the period in which the employee renders the related services.

(b) Post-Employment Benefits :

(i) Defined Contribution Plan :

The Group's contribution paid / payable during the year to Provident Fund, Superannuation Fund and other welfare funds are considered as defined contribution plans. The Contribution paid / payable under these plans are recognised in the Statement of Profit and Loss during the period in which the employee renders the services.

(ii) Defined Benefit Plans :

The Gratuity Scheme managed by Life Insurance Corporation of India through a Trust is considered as defined benefit plan. The present value of the obligation is determined based on actuarial valuation using the Projected Unit Credit Method.

Actuarial gains and losses are recognised immediately in the Statement of Profit and Loss and Other Comprehensive Income.

The fair value of the plan assets is reduced from the gross obligation under the defined benefit plan to recognise the obligation on net basis.

Gains or losses on the curtailment or settlement of any defined benefit plan are recognised when the curtailment or settlement occurs.

(iii) Long term Employee Benefits :

The obligation for long term employee benefits such as long term compensated absences,

long service awards, etc. is recognised in the same manner as in the case of defined benefit plans as mentioned in (b) (i) above except that the actuarial gains and losses are recognised immediately in the Statement of Profit and Loss.

(10) Income Taxes

Income tax expense represents the sum of the tax currently payable and deferred tax.

(a) Current Tax :

The tax currently payable is based on taxable profit for the year. Taxable profit differs from 'Profit Before Tax', as reported in the Statement of Profit and Loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

(b) Deferred Tax :

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit. In addition, deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax liabilities and assets are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realised, based on tax rates and tax laws that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would

follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

(c) Current and Deferred Tax for the Year :

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in Other Comprehensive Income or directly in equity, in which case, the current and deferred tax are also recognised in Other Comprehensive Income or directly in equity respectively.

(11) Property, Plant and Equipment

Freehold land is carried at historical cost. All other items of property, plant and equipment are stated at historical cost less depreciation.

Property, plant and equipment are stated at cost, less accumulated depreciation and impairment, if any. Costs directly attributable to acquisition are capitalised until the property, plant and equipment are ready for use, as intended by management. The Group depreciates property, plant and equipment over their estimated useful lives using the straight line method. The estimated useful lives of the assets are as follows:

Depreciation is recognised so as to write off the cost of assets (other than freehold land and properties under construction) less their residual values over their useful lives, using the straight-line method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis. The useful life as prescribed under Schedule II of the Companies Act have been followed except in respect of the following categories of assets, in whose case the life of the assets has been assessed as under based on technical advice, taking into account the nature of the asset, the estimated usage of the asset, the operating condition of the asset, past history of replacement, anticipated technological changes, manufacturers warranties and maintenance support, etc.:

- Remembraning of Membrane cell elements-4 years
- Recoating of Anode and Cathode membrane cell elements-8 years
- Leasehold land and equipment is amortised over the duration of the lease.

Advances paid towards the acquisition of property, plant and equipment outstanding at each Balance Sheet date

is classified as capital advances under Other Non-Current Assets and the cost of the assets not put to use before such date are disclosed under 'Capital work-in-progress'. Subsequent expenditures relating to property, plant and equipment is capitalised only when it is probable that future economic benefits associated with these will flow to the Group and the cost of the item can be measured reliably. Repairs and maintenance costs are recognized in net profit in the Statement of Profit and Loss when incurred. The cost and related accumulated depreciation are eliminated from the financial statements upon sale or retirement of the asset and the resultant gains or losses are recognised in the Statement of Profit and Loss. Assets to be disposed off are reported at the lower of the carrying value or the fair value less cost to sell.

For transition to Ind AS, the Group has elected to continue with the carrying value of all of its property, plant and equipment recognised as of April 1, 2015 (transition date) measured as per the previous GAAP and considered that carrying value as its deemed cost as of the transition date.

(12) Intangible Assets

Intangible Assets acquired separately :

Intangible assets with finite useful lives that are acquired separately are carried at cost less accumulated amortisation and accumulated impairment losses. Amortisation is recognised on a straight-line basis over their estimated useful lives from the date they are available for use. The estimated useful life and amortisation method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis. Intangible assets with indefinite useful lives that are acquired separately are carried at cost less accumulated impairment losses.

Useful Lives of Intangible Assets :

Estimated Useful lives of the Intangible assets are as follows:

(13) Impairment of Tangible and Intangible Assets other than Goodwill

Intangible assets and property, plant and equipment are evaluated for recoverability whenever events or changes in circumstances indicate that their carrying amounts may not be recoverable. For the purpose of impairment testing, the recoverable amount (i.e. the higher of the fair value less cost to sell and the value-in-use) is determined on an individual asset basis unless the asset does not generate cash flows that are largely independent of those from other assets. In such cases, the recoverable amount is determined for the cash generating unit to which the asset belongs.

If such assets are considered to be impaired, the impairment is recognized in the Statement of Profit and Loss and is measured by the amount by which the carrying value of the assets exceeds the estimated recoverable amount of the asset. An impairment loss is reversed in the Statement of Profit and Loss if there has been a change in the estimates used to determine the recoverable amount. The carrying amount of the asset is increased to its revised recoverable amount, provided that this amount does not exceed the carrying amount that would have been determined (net of any accumulated amortization or depreciation) had no impairment loss been recognized for the asset in prior years.

(14) Inventories

Inventories are stated at the lower of cost and net realisable value after providing for obsolescence. Costs of inventories are determined on weighted average basis. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale. Cost of inventories comprises of cost of purchase, cost of conversion and other costs including manufacturing overheads incurred in bringing them to their respective present location and condition.

(15) Provisions

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, it is probable that the Group will be required to settle the obligation, and a reliable estimate can be made of the amount of the obligation.

(16) Financial Instruments

The Group determines the classification of its financial assets and liabilities at initial recognition. The classification depends on the Group's business model for managing the financial assets and the contractual terms of the cash flows.

Initial Recognition :

The Group recognizes financial assets and financial liabilities when it becomes a party to the contractual provisions of the instrument. All financial assets and liabilities are recognized at fair value on initial recognition, except for trade receivables which are initially measured at transaction price. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities that are not at fair value through profit or loss, are added to the fair value on initial recognition. Regular way purchase and sale of financial assets are accounted for at trade date.

Subsequent Measurement :

(a) Non-derivative financial instruments :

(i) Cash and Cash equivalents :

The Group considers all highly liquid financial instruments, which are readily convertible into known amounts of cash that are subject to an insignificant risk of change in value and having original maturities of three months or less from the date of purchase, to be cash equivalents. Cash and cash equivalents consists of balances with banks which are unrestricted for withdrawal and usage.

(ii) Financial assets carried at amortised cost :

A financial asset is subsequently measured at amortised cost if it is held within a business model whose objective is to hold the asset in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

(iii) Financial assets at fair value through Other Comprehensive Income (FVTOCI) :

A financial asset is subsequently measured at fair value through Other Comprehensive Income if it is held within a business model whose objective is achieved by both collecting contractual cash flows and selling financial assets and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding. The Group has made an irrevocable election for its investments which are classified as equity instruments to present the subsequent changes in fair value in Other Comprehensive Income based on its business model .

(iv) Financial assets at fair value through profit or loss (FVTPL) :

A financial asset which is not classified in any of the above categories are subsequently fair valued through profit or loss.

(v) Investment in Joint Venture :

A joint venture is a joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint arrangement. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when

decisions about the relevant activities require unanimous consent of the parties sharing control.

The Group accounts for its investment in joint venture at cost.

(vi) Financial liabilities :

Financial liabilities are subsequently carried at amortized cost using the effective interest method. For trade and other payables maturing within one year from the Balance Sheet date, the carrying amounts approximate fair value due to the short maturity of these instruments.

(b) Share capital :

Ordinary Shares

Ordinary shares are classified as equity. Incremental costs directly attributable to the issuance of new ordinary shares are recognized as a deduction from equity, net of any tax effects.

Derecognition of financial instruments :

The Group derecognizes a financial asset when the contractual rights to the cash flows from the financial asset expire or it transfers the financial asset and the transfer qualifies for derecognition under Ind AS 109. A financial liability (or a part of a financial liability) is derecognized from the Group's Balance Sheet when the obligation specified in the contract is discharged or cancelled or expires.

(17) Fair value of financial instruments

In determining the fair value of its financial instruments, the Group uses a variety of methods and assumptions that are based on market conditions and risks existing at each reporting date. The methods used to determine fair value include available quoted market prices and valuation reports from independent valuers. All methods of assessing fair value result in general approximation of value and such value may never actually be realized.

(18) Impairment of Financial Assets

The Group recognizes loss allowances using the Expected Credit Loss (ECL) model for the financial assets which are not fair valued through profit or loss. Loss allowance for trade receivables with no significant financing component is measured at an amount equal to lifetime ECL. For all other financial assets, expected credit losses are measured at an amount equal to the 12-month ECL, unless there has been a significant increase in credit risk from initial recognition in which case those are measured at lifetime ECL. The amount of expected credit losses (or reversal) that is required to adjust the loss allowance at the reporting date to the amount that is required to be recognised is recognised as an impairment gain or loss in profit or loss.

(19) Earnings per share

Basic earnings per share are computed by dividing the profit or loss attributable to equity shareholders of the Group by the weighted average number of equity shares outstanding during the period. The Group did not have any potentially dilutive securities in any of the period presented.

(20) First-time adoption-mandatory exceptions and optional exemptions

Overall Principle :

The Group has prepared the opening Balance Sheet as per Ind AS as of April 1, 2015 (the transition date) by recognising all assets and liabilities whose recognition is required by Ind AS, not recognising items of assets or liabilities which are not permitted by Ind AS, by reclassifying items from previous GAAP to Ind AS as required under Ind AS, and applying Ind AS in measurement of recognised assets and liabilities. However, this principle is subject to the certain exceptions and certain optional exemptions availed by the Group as detailed below.

Classification of Debt Instruments :

The Group has determined the classification of debt instruments in terms of whether they meet the amortised cost criteria or the FVTOCI criteria based on the facts and circumstances that existed as of the transition date.

Impairment of financial assets :

The Group has applied the impairment requirements of Ind AS 109 retrospectively; however, as permitted by Ind AS 101, it has used reasonable and supportable information that is available without undue cost or effort to determine the credit risk at the date that financial instruments were initially recognised in order to compare it with the credit risk at the transition date. Further, the Group has not undertaken an exhaustive search for information when determining, at the date of transition to Ind AS, whether there have been significant increases in credit risk since initial recognition, as permitted by Ind AS 101.

Deemed cost for property, plant and equipment and intangible assets :

The Group has elected to continue with the carrying value of all of its plant and equipment and intangible assets recognised as of April 1, 2015 (transition date) measured as per the previous GAAP and use that carrying value as its deemed cost as of the transition date.

Equity investments at FVTOCI :

The Group has designated investment in equity instruments as at FVTOCI on the basis of facts and circumstances that existed at the transition date.

(21) Recent accounting pronouncements

(i) Standards issued but not yet effective :

In March, 2017, the Ministry of Corporate Affairs issued the Companies (Indian Accounting Standards) (Amendments) Rules, 2017, notifying amendment to Ind AS 7, 'Statement of cash flows'. This amendment is in accordance with the recent amendment made by International Accounting Standards Board (IASB) to IAS 7, 'Statement of Cashflows' and IFRS 2. This amendment is applicable to the Group from April 1, 2017.

(ii) Amendment of Ind AS 7 :

The amendment to Ind AS 7 requires the entities to provide disclosures that enable users of financial statements to evaluate changes in liabilities arising from financing activities, including both changes arising from cash flows and non-cash changes, suggesting inclusion of a reconciliation between the opening and closing balances in the balance sheet for liabilities arising from financing activities, to meet the disclosure requirement.

The Group is evaluating the requirements of the amendment and the effect on the financial statements is being evaluated.

(22) Critical judgements in applying accounting policies

The following are the critical judgements, apart from those involving estimations that the management have made in the process of applying the Group's accounting policies and that have the most significant effect on the amounts recognized in the financial statements. Actual results may differ from these estimates. These estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to the accounting estimates in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Useful lives and residual value of property, plant and equipment :

The Group reviews the useful life and residual value of property, plant and equipment at the end of each reporting period. This reassessment may result in change in depreciation expense in future periods.

Allowance for expected credit losses :

Note-12 describes the use of practical expedient by computing the expected credit loss allowance for trade receivables based on provision matrix. The expected credit allowance is based on the aging of the days receivables which are past due and the rates derived based on past history of defaults in the provision matrix.

NOTES TO THE CONSOLIDATED FINANCIAL STATEMENTS

Dismantling cost of property, plant and equipment :

Note-3 describes assets retirement obligation on estimate basis for property, plant and equipment. The management estimates dismantling cost considering size of the asset and its useful life in line with industry practices.

Stores and spares inventories :

The Group's manufacturing process is continuous and highly mechanic with wide range of different types of plant and machineries. The Group keeps stores and spares as standby to continue the operations without any disruption. Considering wide range of stores and spares and long lead time for procurement of it and based on criticality of spares, the Group believes that net realizable value would be more than cost.

Fair value of investments :

The Group has invested in the equity instruments of various companies. However, the percentage of shareholding of the Group in such investee companies is very low and hence, it has not been provided with future projections including projected profit and loss account by those investee companies. Hence, the valuation exercise carried out by the Group with the help of an independent valuer has estimated fair value at each reporting period based on available historical annual reports and other information in the public domain.

Income taxes :

Significant judgements are involved in determining the provision for income taxes, including amount expected to be paid/recovered for uncertain tax positions.

Contingent liability judgement :

Note-42 describes claims against the Group not acknowledged as debt. It includes certain penalties and charges payable to Government agency although as per the contracts, the Management, based on past experience, believes that the penalties and charges are negotiable and not certain and accordingly it is not considered as an obligation as at balance-sheet date and disclosed as contingent liabilities.

Classification of GACL-NALCO Alkalies & Chemicals Pvt. Ltd. as a Joint Venture :

GACL-NALCO Alkalies & Chemicals Pvt. Ltd. is a limited liability company whose legal form confers separation between the parties to the joint arrangement and the Company itself. Furthermore, there is no contractual arrangement or any other facts and circumstances that indicates that the parties to the joint arrangement have rights to the assets and obligations for the liabilities of joint arrangement. Accordingly, GACL-NALCO Alkalies & Chemicals Pvt. Ltd. is classified as a Joint Venture of the Group.

The Group monitors capital by computing the above ratios on an annual basis and ensuring that the same is in Compliance with the requirements of the Financial Covenants.

36.3 Financial Risk Management objectives

The Group's Corporate Treasury Function provides services to the business, co-ordinates access to domestic and international financial markets, monitors and manages the financial risks relating to the operations of the Group through internal risk reports which analyse exposures by degree and magnitude of risks. These risks include market risk (including currency risk, interest rate risk and other price risk), credit risk and liquidity risk.

Compliance with policies and exposure limits is reviewed internally on a continuous basis. The Corporate Treasury does not enter into any trade financial instruments, including derivative financial instruments and relies on natural hedge.

The Corporate Treasury Function monitors risks and policies implemented to mitigate risk exposures on a periodical basis.

36.4 Market Risk

The Group's activities expose it primarily to the financial risks of changes in foreign currency exchange rates and interest rates. The Group currently has not hedged any External Commercial Borrowings (ECBs). The Group performs an analysis of the impact of not hedging its ECBs. This has been done by comparing the actual cash outflows related to ECBs under current unhedged conditions in the past vis-a-vis the scenario of complete hedging of individual ECB on the disbursement day through quotes provided by the banks. Further, the Group parks its earnings in foreign currency in Exchange Earners Foreign Currency (EEFC) account and discharges its obligations in case of foreign currency loans out of the said account.

The Company's investments in listed and non-listed equity securities are susceptible to price risk arising from uncertainties about future value of the investment securities. The Company's non-current investment in equity shares are strategic investments and hence are considered as Fair Value through Other Comprehensive Income. The company's Board of Directors reviews and approves all equity investment decisions.

36.5 Foreign currency risk management

The Group undertakes transactions denominated in foreign currencies; consequently, exposures to exchange rate fluctuations arise. Exchange rate exposures are managed within approved policy parameters. Further, the Group parks its earnings in foreign currency in Exchange Earners Foreign Currency (EEFC) account and discharges its obligations in case of foreign currency loans out of the said account.

36.6 Interest rate risk management

The Group is exposed to interest rate risk because the Group borrows funds at floating interest rates. The risk is managed by the Group by monitoring the exchange rate on regular basis and also parking the export proceeds in the EEFC account which also provides a natural hedge for the outflows in foreign currency. Further, the Group performs an impact analysis of not hedging its ECBs. This has been done by comparing the actual cash outflows related to ECBs under current unhedged conditions in the past vis-a-vis the scenario of complete hedging of individual ECB on the disbursement day through quotes provided by the banks.

Interest rate sensitivity analysis

The sensitivity analysis below have been determined based on the exposure to interest rates for instruments at the end of the reporting period. For floating rate liabilities, the analysis is prepared assuming the amount of the liability outstanding at the end of the reporting period was outstanding for the whole year.

If the interest rates had been 50 basis points higher/lower and all other variables were held constant, the Group's profit before tax for the year ended would be impacted to the extent of Rs.169 Lakhs (Rs.127 lakhs for the year 2015-16).

36.7 Credit Risk Management

Credit risk refers to the risk that the counterparty will default on its contractual obligations resulting in financial loss to the Group. The Group is operating through network of dealers based at different locations. In order to ensure the security of receivables, the Marketing Department computes an exposure ratio for every dealer based on his past turnover, track record, etc. The same is overseen and approved by the Board. Further, the Group also collects bank guarantees / security deposits from the respective dealers. Regular monitoring of the receivables is undertaken by the Marketing Department and in case the limits are exceeded, an auto lock system is in place in the existing ERP of the Group to stop further supplies to the concerned dealer till the amount outstanding is recovered. In case of new customers, the goods are supplied only against advance receipts. For the export made by the Group, the sales are backed by letters of credit or advance receipts. The internal risk management committee of the Group meets regularly to discuss the dealers and credit risks, measures taken to address them and the status and level of risk after the measures taken.

Domestic trade receivables are secured to the extent of interest free security deposits and bank guarantees received from the customers amounting to Rs.4,520.08 lakhs, Rs.4,159.64 lakhs and Rs.4,064.64 lakhs as at 31st March, 2017, 31st March, 2016 and 1st April, 2015 respectively. Export sales are fully secured through letters of credit or against advance receipts. (refer Note No. 12 for Trade Receivables outstanding).

36.8 Liquidity risk management

Ultimate responsibility for liquidity risk management rests with the Board of Directors, which has established an appropriate liquidity risk management framework for the management of the Group's short-term, medium-term and long-term funding and liquidity management requirements. The Group manages its funds mainly from internal accruals. The liquidity risk is managed by maintaining adequate reserves and banking facilities, by continuously monitoring forecast and actual cash flows and by matching the maturity profiles of financial assets and liabilities.

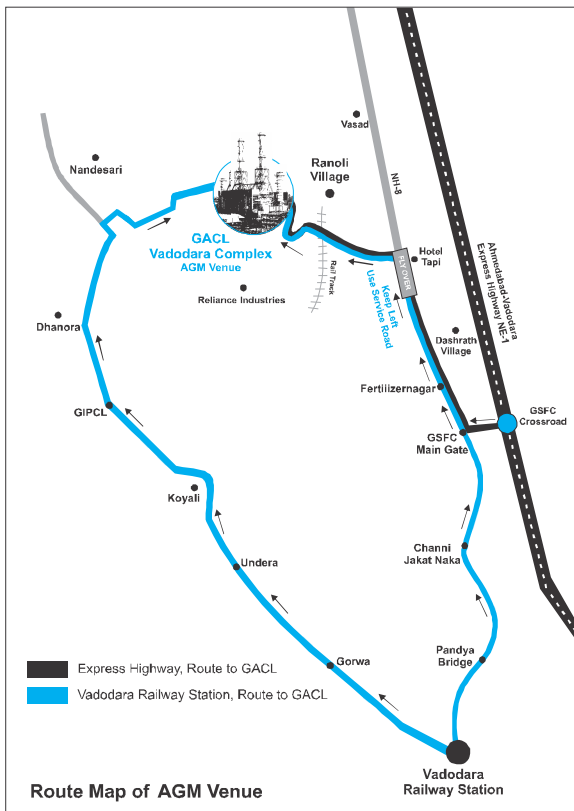

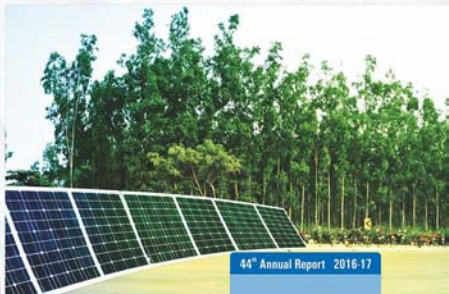
