35 विधायकों को खाली करना होगा विश्राम गृह

वित्त विभाग ने किया किराया देने से इनकार

भोपाल,(निप्र)। मध्य प्रदेश विधानसभा के 35 विधायकों को विधानसभा सचिवालय ने विधायक विश्राम गृह खाली करने के लिए नोटिस कमाया है। पुराने विश्रामगृह को तोड़कर 102 फ्लैट यहां पांच टावर का विधायक विश्रामगृह यहां बनाया जाना है। जो विधायक विश्रामगृह खाली करेंगे। उन्हें दूसरे प्राइवेट आवास लेने के लिए 40 हजार रुपए महीना किराया भुगतान किया जाना है लेकिन फिलहाल वित्त विभाग ने इतना किराया देने के लिए इनकार कर दिया है। विश्रामगृह खाली करने के लिए दिया गया नोटिस-दरअसल विधानसभा ग्रह को तोड़कर विधायकों के लिए नए आवास बनाए जाने हैं। इसके लिए विधायकों को विश्रामगृह खाली करने के लिए नोटिस दिया गया है। वहीं पुराना विश्रामगृह में रहने वाले 14 और विधायकों को विधायक विश्रामगृह खाली करने के लिए नोटिस दिया गया है। 102 फ्लैट करने वाले पांच मंजिला टावर का निर्माण 17 महीने में पूरा किया जाना है। नए विश्रामगृह में विधायकों को ज्यादा जगह और अतिरिक्त सुविधाएं दी जाएगी। निजी आवास में रहने लिए किराया दिया जाएगा-नए विश्राम के निर्माण की अवधि तक विधायक को निजी आवास लेने के लिए किराया दिया जाएगा। प्रतिमान 40 हजार रुपए किराया विधायकों को इस दौरान देने के लिए प्रस्ताव वित्त विभाग को भेजा गया है लेकिन वित्त विभाग इतना किराया देने के लिए तैयार नहीं है। इसलिए वित्त की सहमति अभी तक नहीं पाई है। जिसके चलते विधायक के पुराने विश्राम गृह को रिक्त नहीं कर रहे हैं। विधानसभा सचिवालय विधायकों के लिए सरकारी आवास भी देख रहा है। खाली होने पर उनके लिए सरकारी आवास भी आवंटित किए जा सकते हैं। दो पूर्व विधानसभा अध्यक्षों को सरकारी आवास आवंटित-पूर्व विधानसभा अध्यक्ष गिरीश गौतम को 16 बंगले में प्रभात झा का आवंटित किया बंगला दे दिया गया है। वहीं पूर्व विधानसभा अध्यक्ष सीता शरण शर्मा ने भी पुराना बंगला खाली करके नया सरकारी आवास ले लिया है। इसलिए इन दोनों को किराया निजी आवास लेने के लिए नहीं मिल पाएगा। जो भी विधायक सरकारी आवास लेंगे। उन्हें भी किराए का भुगतान नहीं किया जाएगा।

**HIMACHAL PRADESH** continues to reel under the impact of the ongoing monsoon season, with 1,087 roads, 2,838 power supply lines, and 509 water supply schemes disrupted across the state as of Friday evening, according to the State Disaster Management Authority (SDMA). The disaster toll has climbed to 360 deaths since June 20, 2025.

**MAHARASHTRA:** Heavy rains in the past few days have damaged crops on 14.44 lakh hectares of land in 29 districts of Maharashtra. state agriculture minister Dattatray Bharane said on Friday. The maximum damage was reported between August 15 and 20, when the monsoon was highly active, he said. Excess rainfall hit 191 talukas, causing damage to Kharif crops in 654 revenue circles.

**DELHI:** The national Capital and its adjoining regions are bracing for another spell of heavy rains. IMD has forecast continuous showers across Delhi-NCR between September 5 and September 10. According to the weather department, moderate rainfall with normal cloud cover is expected on September 5, while September 6 and 7 are likely to witness heavy rains.
